7 "(b) A load-serving entity shall provide an alternative type of net metering
8 service for a consumer-generator that exports an insignificant amount of excess
9 electric energy to the load-serving entity and does not receive compensation for any
10 excess electric energy generation. A load-serving entity shall offer streamlined
11 approval for this type of net metering service under regulations adopted by the
12 commission and prioritize applications for this type of net metering service over
13 applications for the net metering service under (a) of this section."

1 (h) This section applies only to load-serving entities that are served by an
2 electric reliability organization and have total retail sales exceeding 5,000,000
3 kilowatt-hours during a calendar year."
