**FISCAL NOTE ANALYSIS**

**BILL NO. SB205**

**Analysis**

This bill changes the occupational disability benefit amount for peace officers and firefighters in all Tiers in the Public Employee Retirement System (PERS) from 40% of the member's gross monthly compensation at termination after twelve (12) months of receiving disability benefits to 75% of the member's gross monthly compensation at termination. This bill will take effect immediately under AS 01.10.070(c).

This bill does not cost the division any additional resources to implement.
