A RESOLUTION

1 **Supporting the extension of the national emergency declared in Executive Order 14024;**
2 **supporting the continued national prohibition on Russian seafood imports effected by**
3 **Executive Orders 14024, ~~14066~~14068, and ~~14068~~14114; and urging the President of the**
4 **United States, federal agencies, and the United States Congress to consider additional**
5 **measures necessary for prohibiting the importation of Russian seafood into the United**
6 **States and to maintain and strengthen federal measures that ensure fair trade, protect**
7 **the state's seafood industry, and promote sustainable and ethical seafood production.**

8 **BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF ALASKA:**

9 **WHEREAS** the state's seafood industry contributes over \$5,000,000,000 annually to
10 the economy of the state, ~~\$125~~160,000,000 in state, municipal, and federal taxes, and
11 ~~\$7,300~~15,000,000,000 in total United States economic activity; and

1 **WHEREAS** the state's seafood industry produces over 60 percent of the wild seafood
2 commercially harvested in the United States; and

3 **WHEREAS** the state's seafood industry brought in an annual average of
4 \$1,500,000,000 in ex-vessel value in 2023 and 2024 and employed over 19,000 commercial
5 fishermen, 58 percent of whom were state residents; and

6 **WHEREAS** the state's seafood industry ~~accounts~~is also the state's largest
7 manufacturing sector, accounting for 62 percent of all state residents employed in
8 manufacturing, which is over 21,000 workers; and

9 **WHEREAS** the state's seafood industry faces an existential and global threat in the
10 form of unfair trade and market practices by Russian seafood producers that drive down the
11 cost of seafood around the world and prevent seafood companies in the state from competing
12 on fair terms; and

13 **WHEREAS** Russia exported 70,000 metric tons of Russian-origin cod, pollock, and
14 salmon into the United States in 2022, at a value of over \$452,000,000; and

15 ~~**WHEREAS** Russia has dramatically increased seafood production since 2022,~~
16 ~~removing key sustainability sideboards from Russia's fisheries management; and~~

17 **WHEREAS** the price of Russian seafood is artificially low because of factors that
18 include state-subsidized construction of fishing vessels and processing plants, exploitation of
19 workers, and lax environmental protections; and

20 **WHEREAS** Russian seafood competes directly with the state's seafood in global
21 markets, driving down prices and preventing companies in the state from competing on fair
22 terms; and

23 **WHEREAS** the dumping of Russian seafood into global markets after the 2022
24 Russian invasion of Ukraine contributed to a crisis in the state's seafood industry; and

25 **WHEREAS** the National Oceanic and Atmospheric Administration has found that
26 declines in the state's seafood industry in 2022 and 2023 resulted in more than 38,000 job
27 losses nationwide and a loss of \$4,300,000,000 in total United States output; and

28 **WHEREAS** the state's seafood industry abides by strict state and national laws and
29 prioritizes the ethical treatment and fair compensation of workers; and

30 **WHEREAS** Russia has banned the importation of the state's seafood products since
31 2014, depriving the state's seafood sector of a historically important export market; and

1 **WHEREAS** the United States is the largest market for the state's seafood products,
2 accounting for approximately one-third of total annual sales of the state's seafood; and

3 **WHEREAS** the removal of Russian products from the United States domestic market
4 ~~is a reasonable response to the closure of the Russian market to United States seafood,~~
5 ~~provides a fair opportunity~~ensures fairness for domestic seafood producers ~~to balance sales~~
6 ~~and recover lost profits, and ensures that consumers in the United States receive the highest,~~
7 makes quality seafood available to American consumers, and enables consumers to replace
8 Russian seafood products with seafood from the state; and

9 ~~**WHEREAS** the National Oceanic and Atmospheric Administration found that~~
10 ~~declines in the state's seafood industry in 2022 and 2023 resulted in more than 38,000 job~~
11 ~~losses nationwide and a \$4,300,000,000 loss in United States gross domestic product; and~~

12 **WHEREAS**, on April 15, 2021, Executive Order 14024, ~~establishing~~ established a
13 national emergency to address threats posed by Russia, and, on March 11, 2022, Executive
14 Order 14068 prohibited the ~~direct import~~importation of Russian seafood products into the
15 United States; and

16 **WHEREAS**, on December 22, 2023, Executive ~~Orders 14066 and 14068, issued on~~
17 ~~March 8 and March 11, 2022, respectively,~~Order 14114 broadened the scope of ~~that~~
18 ~~prohibition, banning the import~~federal action, prohibiting the importation of ~~Russian all~~
19 ~~seafood harvested by Russia, regardless of whether the~~ seafood ~~products entering the United~~
20 ~~States through~~ was substantially transformed in a ~~third-party countries~~ country; and

21 **WHEREAS** ~~the executive orders were~~Executive Order 14024 was extended for an
22 additional year on April 10, 2025, and ~~are~~is scheduled to expire April 15, 2026;

23 **BE IT RESOLVED** that the Alaska State Legislature strongly supports the further
24 extension and ~~further~~ enforcement of ~~the executive orders that~~Executive Orders 14024,
25 14068, and 14114, which prohibit the importation of Russian seafood products into the United
26 States; and be it

27 **FURTHER RESOLVED** that the Alaska State Legislature urges President Trump,
28 federal agencies, the Alaska Congressional delegation, and the entirety of the United States
29 Congress to consider additional measures necessary for prohibiting the importation of Russian
30 seafood into the United States and to maintain and strengthen measures that ensure fair trade,
31 protect the state's seafood industry, and promote sustainable and ethical seafood production.

8 Representative, members of the Alaska delegation in Congress.
