DNR seeks applicants for Farm to School mini-grants

(Fairbanks, AK) - The Division of Agriculture is seeking applications for its annual Farm to School mini-grants starting on March 1.

The goal of the division's Farm to School (FTS) program is to encourage healthy eating and boost local agriculture sales by bringing Alaska Grown vegetables, fruit and other products into local schools. Mini-grants are available for school-based FTS projects that connect students, teachers, and school food service staff with products grown and produced in Alaska. The maximum grant per project is \$1,000.

2012 Alaska Farm to School Program Request for Proposals ~ Application Deadline April 23, 2012

To: Interested Alaska Farm to School Supporters

The Division of Agriculture is soliciting proposals for Farm to School (FTS) projects promoting activities that connect students, teachers, community, and the school food service with product grown or produced in Alaska.

The Division of Agriculture intends to award multiple contracts from this solicitation. Maximum state funds to be allocated per project are \$1,000.

The purpose of the FTS project is:

- To increase Alaska youth understanding about how food gets from its original form to the plate;
- To promote healthy food choices, and
- To encourage a preference for food grown and harvested in Alaska.

Requirements of the contract will include:

- Promotion of a Farm to School project or activity, not an individual business;
- Inclusion of a school food service professional (can be at the district level or school level). **At a minimum a letter of support from the food service professional is required, projects that demonstrate a coordinated effort with food service will be given priority;**
- Inclusion of an expert, specialist, or mentor in the community (i.e. cooperative extension services, FFA, 4-H, master gardener, Farmer, Chef, or other);
- A final report (simple reporting form will be provided), including required documentation and receipts.

Applicants should submit proposals using the proposal requirements listed in the application. The entire application package can be found on our web site www.dnr.alaska.gov/ag under the "Grants" tab.

Proposals will be evaluated based on the:

- Relative need for the proposed activity;
- Importance of the problem to be addressed;
- Benefits likely to be derived from the project in relation to the funds requested;
- Demonstrated support and collaboration of required expertise;
- Project evaluation methods and media plan; and
- Previous project performance

Proposals must be received at either the Central or Northern Region Division of Agriculture offices (see above addresses) by 5:00 pm on Monday, April 23, 2012.

"To responsibly develop Alaska's resources by making them available for maximum use and benefit consistent with the public interest."

Selected proposals will be announced and awarded no later than May 15, 2012. Project documentation and final report forms must be complete and submitted to the Northern Regional office of the Division by 5:00 pm on December 21, 2012. Projects received *after that time and date* will be considered late and influence evaluation points given on future proposals.
