

- 1967 Troopers




## **Department Success**

- Since 2018 overall crime rate has decreased 37% and drug seizures have increased 733%
- Number of felony sex offenses has decreased 27% statewide (2023 to 2024)
- No backlog of sexual assault examination kits awaiting testing at the Alaska Crime Lab
  - 2024: established online system for victims of sexual assault to track their sexual assault examination kit
- 2024: the Alaska State Troopers (AST) awarded as the US Postal Services
   National Exemplary partner after AST was identified as the most productive
   law enforcement agency in the country working with USPS to interdict drugs
- Troopers seized 1,262 pounds of illegal narcotics across the state including approximately 42 million potentially fatal doses of fentanyl in 2024

## **Division of Alaska State Troopers (AST)**

#### **Accomplishments**

76% Increase in total amount of illegal drugs and alcohol seized from 2023 to 2024

Addition of Trooper Recruiter doubled recruitment events attended

Advanced Training Unit (ATU) trained 482 commissioned positions

2,500 Peer Support Program contacts




# Statewide Drug/Alcohol Enforcement Unit (SDEU)

- Fairbanks Areawide Narcotics Team (FANT) focuses on drug interdictions and investigations in the Interior Region, Utgiagvik, and east to Canada
  - **Southcentral Areawide Narcotics Team (SCAN)** focuses on drug interdictions and investigations throughout the Mat-Su Valley, Anchorage, Kenia Peninsula, and Kodiak Island
  - Western Alaska Alcohol and Narcotics Team (WAANT) focuses predominately on alcohol enforcement in Western Alaska as well as drug interdictions and investigations
- **Southeast Alaska Cities Against Drugs (SEACAD)** focuses on drug interdictions and investigations in Southeast Alaska

#### **Accomplishments**

- 97% increase in education hours on Boating Safety Education
- 108% increase in Boating Safety Contacts
- 12% increase in Resource User Contacts

#### **Challenges**

- 6,640 miles of coastline, significant hunts and fisheries
- Complicated regulatory structure and limited resources; 891,000 licenses sold and 90 Troopers



### **Aircraft Section**

- Law enforcement response/investigation
- Search and rescue
- Wildlife resource protection
- Prisoner transport
- Fleet
  - 49 fixed wing and rotor wing aircraft
  - Aircraft are based in 19 locations
  - 6,141 hours flown in 2024 (calendar year)

### **Marine Section**

- Marine fisheries enforcement
- Search and rescue
- Fleet management 41 vessels
  - New Large Class Vessel (funded FY25)
  - Two 35' vessels and three patrol skiffs being built to replace older vessels
  - P/V Stimson, Kodiak (156' deployable statewide)
  - P/V Cama'i, Kodiak (69' catamaran)
  - 13 medium-sized vessels (27' to 35') in 12 different communities
  - Multiple other small skiffs and river boats





## Village Public Safety Officer (VPSO) Division

#### **Program Status**


- \$22,337.5 awarded in FY25 (\$ in thousands)
- 10 grantees, agreements with 156 villages
- 85 VPSOs in 65 communities

#### **Accomplishments**

- 50% growth FY2021 to FY2025
- Implementation of Regional Public Safety Officer (RSPO) program
- 80% VPSO graduation rate and retention rate

#### **Challenges**

- Funding Limitations
- Strain on Division Staffing
- Infrastructure Challenges
- Recruitment and Retention

#### **Mission**

To prevent the loss of life and property from fire and explosion

#### **FY24 Accomplishments**

- FY24: 988 building fire and life safety inspections
- FY24: 182% increase in buildings in compliance with legal standards according to inspections
- Calendar year 2022 to 2023: \$7 million decrease in property loss

#### **Challenges**

- Rural fire department capacity
- Communication methods to read the risk groups and areas regarding

## **Statewide Support**

#### **Criminal Justice Information Services (CJIS)**

- Maintain the State's criminal history repository used by law enforcement and for processing applicant background checks
- Maintain the State's sex offender registry, concealed handgun permits, and civilian process server and security guard licensing programs

#### **Alaska Police Standards Council (APSC)**

Certification and standards for statewide peace officers

#### **Alaska Public Safety Communications Services (APSCS)**

Provide public safety infrastructure, services, and support to first responders

## Statewide Support Alaska Public Safety Communications Services

#### **Accomplishments**

• Supported first responders and other authorized users on the Alaska Land Mobile Radio (ALMR) system with over 17,656,971 radio calls that had a combined number of 28,962,175 push-to-talks in FY2024

## Statewide Support Information Services

#### **Accomplishments**

- Developed and deployed an Online Criminal History Request portal to allow the public the option to obtain name-based background checks instead of in person requests
- Deployed and manage 35 Starlink devices to improve bandwidth projects at various Trooper locations, including on vessels
- Continued extensive work with the Criminal Justice Information Services (CJIS) Program and several vendors as
  part of a multi-year, multi-million-dollar project to modernize the State's criminal history repository, sex
  offender registry, concealed handgun permits, and "hot file" records (warrants, missing persons, protective
  orders, stolen property, etc.)

## Statewide Support Criminal Justice Information Services (CJIS) Program

#### **Accomplishments**

- Worked with local, state, and federal law enforcement agencies on the changes to sex offender registration forms, requirements, and processes that resulted from HB 66 (passed by the Alaska Legislature in 2024) which enabled the State to further comply with the federal Sex Offender Registration and Notification Act
- Processed nearly 54,000 criminal history disposition records and nearly 2,100 concealed carry permits/renewals
- Processed over 20,000 fingerprint-based background checks with an average processing time of four days in calendar year 2024

# Scientific Crime Detection Laboratory (Alaska Crime Lab)

<u>Mission</u>: provide scientific support to the criminal justice system to help create a safer Alaska.

- Forensic Analysis
  - Over 17,000 items of evidence was submitted to the lab for testing in 2024
  - Forensic Scientists testified over 90 times across Alaska
- Breath Alcohol Testing Program
- Training and Education
  - 500 hours of training provided to criminal justice system partners
- Forensic Science Hit Outcome Program
  - Allows investigators to track all DNA hits for their agency
  - Deployed statewide August 2024





## Council on Domestic Violence and Sexual Assault (CDVSA)

#### **Mission**

Prevention of domestic violence and sexual assault, providing safety for victims through a statewide system of crisis intervention and support and by supporting perpetrator accountability and rehabilitation.

#### **Accomplishments**

- Provided funding to 35 community-based programs
  - Subgrantees implemented 57 primary prevention strategies and activities
- Provided funding for 277 individuals to participate in Perpetrators of Violence programs
- Increased media messaging
  - Domestic Violence Awareness Month October
  - Teen Dating Violence Awareness Month February
  - Sexual Assault Awareness Month April

#### **Challenges**

- Victims of Crime Act (VOCA) Federal funding will likely be reduced SFY2027, impacting subgrantees
- Increasing federal audits
- Recruitment and retention

## **Violent Crimes Compensation Board (VCCB)**

#### Accomplishments

- Over \$1,256,000 was distributed to victims from 80 communities across Alaska
- Over 25% more applications were processed compared to FY23
- The Board worked to update policies and procedures to ensure equitable and efficient allocation of available funds

#### **Challenges**

Federal funding is based on victim grant award amounts
