**Analysis**

This bill repeals the statutory authority for the Child Care Facility Revolving Loan Fund administered by the Department of Commerce, Community, and Economic Development. The department does not anticipate fiscal impacts associated with the repeal. Any administrative tasks related to closing or removing the program from statute, including regulatory updates and accounting adjustments, can be absorbed within existing resources.
