- Section 9** The following changes were made to **NEW** Section 9:
1. Inserted new section 9 amending AS 44.88.159(b) to clarify that the interest rates on a loan purchased with the proceeds of taxable bonds for an energy project are consistent with current practice.
- Section 10** Section 10 retains the language previously found in section 8:
1. No changes.
- Section 11** The following changes were made to **NEW** section 11:
1. Inserted new section amending AS 44.85.159(e) to clarify that the interest rates, financial securities, cost of funds and minimum interest rates for energy projects financed through the SETS program are consistent with current practice.
- Section 12** The following changes were made to **NEW** Section 12:
1. Inserted a new section amending AS 44.88.159(g) to clarify that loans for an energy project qualify for the incentive rate provisions of AS 44.88.085(g)(2)(C) consistent with current practice.
- Section 13** Section 13 retains the language previously found in section 9:
1. No changes.
- Section 14** Section 14 retains the language previously found in section 10 with the following changes:
1. To **sec. 44.88.730(3)** deleted the words "subject to lender approval" because the language was unnecessary given that AIDEA is the lender.
 2. To **sec. 44.88.730** added new (7) clarifying that AIDEA can borrow money or issue bonds subject to AS 44.88.090 to carry out the purposes of this section.
- Section 15** Section 15 retains the language previously found in section 11 with the following changes:
1. Inserted "heat or" before "electricity" in the definition of an energy project to clarify that projects which generate heat are included in the definition of an energy project.
- Section 16** Section 16 retains the language previously found in section.
