FISCAL NOTE ANALYSIS

STATE OF ALASKA
2026 LEGISLATIVE SESSION

Analysis

This bill adds civics education and assessment to the list of secondary school graduation requirements.

The State Board of Education must develop and maintain: 1) a statewide civic education and comparative government curriculum, 2) a 100 question civic assessment based on the civics portion of the naturalization examination used by the United States Citizenship and Immigration Services of the Department of Homeland Security, 3) a civics project-based assessment, 4) regulations to identify students who have attained a high level of proficiency in civic knowledge, civic skills, a civic mindset, and civic experiences, 5) a seal of civic readiness that may be attached to a student's school transcript and diploma. Students must receive a passing score of 70 percent or more on one of the assessments in order to receive a secondary school diploma.

This fiscal note contains the following one-time expenses: 1) \$640.0 for a facilitator to convene 20 educators and qualified stakeholders for their participation in the development of a secondary school, semester long civics course/curriculum; a 100 question civics assessment; a civics project-based assessment; a process for identifying students who have attained a high level of proficiency in civics; and costs for stipends, travel, and facilitation fees; 2) \$151.3 for a full-time Social Studies Standards content expert to support the development and ongoing implementation of the statewide civics curriculum and assessment; 3) \$5.0 supplies and equipment for the new position; 4) \$22.8 for employee chargebacks; 5) \$200.0 for a facilitator to convene 20 educators and qualified stakeholders for a review and update of the statewide curriculum and assessment in year 5 of the program; 6) \$12.0 for the design, printing, and shipping of a civic education seal; 7) \$6.0 for legal fees to implement the necessary regulation changes.

This fiscal note contains the following annual costs: 1) 151.3 for a full-time Social Studies Standards content expert to support the ongoing implementation of the statewide civics curriculum and assessment; 2) \$22.8 for employee chargebacks, 3) \$5.0 for printing and sending civic education seals to districts.
