BILL NO. SB 153

Analysis

SB 153 amends AS 44.62.310(d) within Article 6: Open Meetings of Governmental Bodies by removing language that currently limits the Open Meetings Act exemption for municipal service area boards established under AS 29.35.450–29.35.490 to meetings addressing solely administrative or managerial matters.

By deleting this condition, the bill would extend the exemption to all meetings of these boards, regardless of the topics discussed. This may decrease public participation in local governance for municipal service area boards.

The Division of Community and Regional Affairs (DCRA) does not anticipate fiscal impacts from this legislation.
