FISCAL NOTE ANALYSIS

BILL NO. SB 276

Analysis

This bill amends AS 21.42 by adding a new section that requires a health care insurer to provide coverage for prescription contraceptives and associated medical services and to provide reimbursement for a 12-month supply of contraceptives. The bill's provisions apply to state and municipal employee health benefit plans, Medicaid, and plans subject to Title 21.

This bill amends Title 21 to require individual and group health care insurance plans to reimburse a health care provider or dispensing entity for providing 12-month prescription of contraceptives, including refills, regardless of whether the insured was enrolled in the health care insurance plan at the time of the first dispensing. The bill exempts certain religious employers from the obligation.

The Division of Insurance does not anticipate fiscal impact from this legislation, because the coverage requirement is not in excess of federal coverage standards.
