11 elections. The following directives shall be followed when applicable:

12 (1) The director shall determine the size of the ballot, the type of print,
13 necessary additional instruction notes to voters, and other similar matters of form not
14 provided by law.

15 (2) The director shall number ballots in series to ensure simplicity and
16 secrecy and to prevent fraud.

17 (3) The director shall contract for the preparation of ballots under
18 AS 36.30 (State Procurement Code).

19 (4) The director may not include on the ballot, as a part of a candidate's
20 name, any honorary or assumed title or prefix but may include in the candidate's name
21 any nickname or familiar form of a proper name of the candidate.

22 (5) The names of the candidates shall be placed in separate sections on
23 the state general election ballot under the office designation to which they were

1 nominated. If a candidate is registered as affiliated with a political party or political
2 group, the party affiliation, if any, may be designated after the name of the candidate,
3 upon request of the candidate. If a candidate has requested designation as nonpartisan
4 or undeclared, that designation shall be placed after the name of the candidate. If a
5 candidate is not registered as affiliated with a political party or political group and has
6 not requested to be designated as nonpartisan or undeclared, the candidate shall be
7 designated as undeclared. The lieutenant governor and the governor shall be included
8 under the same section. Provision shall be made for voting for write-in candidates
9 within each section. Paper ballots for the state general election shall be printed on
10 white paper.

11 (6) The names of the candidates for each office shall be set out in the
12 same order on ballots printed for use in each house district. The director shall
13 randomly determine the order of the names of the candidates for state representative
14 for each house district. The director shall rotate the order of placement of the names of
15 candidates for governor, lieutenant governor, United States senator, United States
16 representative, and state senator on the ballot for each house district.

17 (7) The general election ballot shall be designed with the names of
18 candidates of each political party, and of any independent candidates qualified under
19 AS 15.30.026, for the office of President and Vice-President of the United States
20 placed in the same section on the ballot rather than the names of electors of President
21 and Vice-President. **Provision shall be made for voting for write-in candidates for**
22 **President and Vice-President.**

23 (8) The general or special election ballot shall be designed with the
24 title and proposition for any initiative, referendum, or constitutional amendment
25 formulated as prescribed by law and placed on the ballot in the manner prescribed by
26 the director. When placed on the ballot, a state ballot proposition or ballot question
27 shall carry the number that was assigned to the petition for the proposition or question.
28 Provision shall be made for marking the proposition "Yes" or "No."

29 (9) The general or special election ballot shall be designed with the
30 question of whether a constitutional convention shall be called placed on the ballot in
31 the following manner: "Shall there be a constitutional convention?" Provision shall be

1 made for marking the question "Yes" or "No."

2 (10) A nonpartisan ballot shall be designed for each judicial district in
3 which a justice or judge is seeking retention in office. The ballot shall be divided into
4 four parts. Each part must bear a heading indicating the court to which the candidate is
5 seeking approval, and provision shall be made for marking each question "Yes" or
6 "No." Within each part, the question of whether the justice or judge shall be approved
7 or rejected shall be set out in substantially the following manner:

8 (A) "Shall be retained as justice of the supreme court for
9 10 years?";

10 (B) "Shall be retained as judge of the court of appeals for
11 eight years?";

12 (C) "Shall be retained as judge of the superior court for six
13 years?"; or

14 (D) "Shall be retained as judge of the district court for four
15 years?"

16 (11) When the legislature by law authorizes a state debt for capital
17 improvements, the director shall place the question of whether the specific
18 authorization shall be ratified by placing the ballot title and question on the next
19 general election ballot, or on the special election ballot if a special election is held for
20 the purpose of ratifying the state debt for capital improvements before the time of the
21 next general election. Unless specifically provided otherwise in the Act authorizing
22 the debt, the ballot title shall, by the use of a few words in a succinct manner, indicate
23 the general subject of the Act. The question shall, by the use of a few sentences in a
24 succinct manner, give a true and impartial summary of the Act authorizing the state
25 debt. The question of whether state debt shall be contracted shall be assigned a letter
26 of the alphabet on the ballot. Provision shall be made for marking the question
27 substantially as follows:

28 "Bonds..... Yes" or "Bonds..... No,"

29 followed by an appropriate oval.

30 (12) The director may provide for the optical scanning of ballots where
31 the requisite equipment is available.

1 (13) The director may provide for voting by use of electronically
2 generated ballots by a voter who requests to use a machine that produces electronically
3 generated ballots.

4 (14) The director shall include the following statement on the ballot:

5 A candidate's designated affiliation does not imply that
6 the candidate is nominated or endorsed by the political
7 party or group or that the party or group approves of or
8 associates with that candidate, but only that the
9 candidate is registered as affiliated with the political
10 party or political group.

11 (15) Instead of the statement provided by (14) of this section, when
12 candidates for President and Vice-President of the United States appear on a general
13 election ballot, the director shall include the following statement on the ballot:

14 A candidate's designated affiliation does not imply that
15 the candidate is nominated or endorsed by the political
16 party or political group or that the political party or
17 political group approves of or associates with that
18 candidate, but only that the candidate is registered as
19 affiliated with the party or group. The election for
20 President and Vice-President of the United States is
21 different. Some candidates for President and Vice-
22 President are the official nominees of their political
23 party.
