Analysis

HB 363 expands the privileges of patriotic organizations operating under a club license. This bill would allow patriotic organizations to sell alcoholic beverages at events organized by the organization under a permitting system. This does not create or eliminate a currently existing permit.

The Alcohol and Marijuana Control Office does not anticipate a fiscal impact from this legislation.
