Re: SB 10 – Hunting/Trapping/Fishing Disabled Veterans

Dear Senator Kiehl,

Resident Hunters of Alaska firmly **supports** SB 10, which would include a free trapping license along with the free hunting & fishing license the state currently provides to honorably discharged disabled veterans.

A similar program for Alaskans 60 years of age and older provides a free hunt/fish/trap license. It was likely an oversight that a free trapping license was not originally provided to service-disabled veterans with the free hunting & fishing license.

The Alaska Department of Fish & Game believes the number of applicants for this license will be minimal. We don't believe this will result in a reduction in funding to the Division of Wildlife Conservation, and urge legislators to support this bill.

Dear Senators Bishop, Giessel, and members of the Senate Resources Committee,

The Safari Club International Alaska Chapter supports Senate Bill 10 HUNTING/TRAPPING/FISHING: DISABLED VETS.

Founded in 1971, Safari Club International is the country's leading hunter rights advocate and additionally promotes worldwide wildlife conservation. SCI's approximately 50,000 members and 200 Chapters represent all 50 of the United States as well as 106 other countries. The Safari Club International Alaska Chapter (SCI-AK) is a 501c4 conservation non-profit Corporation established in Alaska in 1977. We currently have 720 members. Our mission statement is "First for Hunters - First for Wildlife."

This legislation inserts a section from AS 16.05.341, free license for disabled veterans and active members of the Alaska National Guard, and military reserves, to the permanent identification card (PID) statutes. The permanent identification card is a free hunting, fishing, and trapping license for residents over 60 years old with no annual renewal.

Currently, resident disabled veterans may obtain a free hunting and fishing license from the department however, trapping licenses are not included. Adding this section to the PID statute would provide a free trapping license for disabled veterans and would also provide a license without the need for annual renewal.

Outdoor activities are proven to benefit mental and physical well-being. Many veterans are older, some suffer from combat wounds or PTSD. Increasing access to healthy outdoor activities is an excellent way to honor Alaska's veteran population while incurring little cost to the state.

We thank Senator Kiehl for introducing SB 10 and offer our full support for this valuable piece of legislation.
