## FISCAL NOTE ANALYSIS

STATE OF ALASKA  
2026 LEGISLATIVE SESSION

BILL NO. SB281

### Analysis

SB281 establishes the Rural Health Transformation Program Advisory Council along with associated compact commissions that carry administrative obligations such as staffing, rulemaking, compliance monitoring, and meeting support; the bill adds a physician assistant to the State Medical Board and defines licensure and scope-of-practice standards, implements the Interstate Medical Licensure Compact and the PA Licensure Compact, adopts the Psychology Interjurisdictional Compact, recognizes the EMS Personnel Licensure Interstate Compact, and provides expedited licensure for veterans and active-duty service members.

SB281 amends multiple sections of the Alaska Statutes (AS), such as:

- AS 08.64.010: updates the composition of the State Medical Board to include a licensed Physician Assistant
- AS 08.64.101: expands board responsibilities to include regulation of compacts (Interstate Medical Licensure Compact and PA Licensure Compact)
- AS 08.64.107: repeals and reenacts the statute defining the Physician Assistant scope of practice and collaborative agreement requirements
- AS 08.64.190, AS 08.64.206, AS 08.64.230, and AS 08.64.250: are amended to add provisions for PA licensure qualifications, expedited licensing, and credentialing by endorsement.

It also enacts new statutory sections to implement the Interstate Medical Licensure Compact and the PA Licensure Compact, formalizing these interstate agreements in Alaska law.

The bill does not specify its own effective date. It would therefore automatically become effective 90 days after the end of the legislative session in which it is passed, at 12:01 A.M. Alaska Standard Time.

There is no anticipated fiscal impact; therefore, this is a zero fiscal note.
