FISCAL NOTE ANALYSIS

STATE OF ALASKA
2025 LEGISLATIVE SESSION

Analysis

HB 28 creates a new student loan repayment three-year pilot program to provide a monetary incentive for Alaskans who now reside outside of Alaska to return home and teach or work in State public service positions and establishes eligibility criteria. A grant may be awarded to a person employed as a full-time certificated teacher in a public school upon completion of the person's contract term or to an individual employed as a full-time employee of the State of Alaska, upon their merit anniversary date. The grant may be distributed each year for a maximum of three years to repay an outstanding student loan for a degree or certificate program located outside the state or from the University of Alaska. If the student loan totals \$24,000 or more, the person is eligible for a grant of \$8,000 each year or if the outstanding student loan totals less than \$24,000, the person is eligible for a grant of one third of the outstanding student loan balance.

Up to 125 grants may be awarded each fiscal year not to exceed \$1,000.0 per fiscal year for a total of \$3,000.0 over three years.

Additional administrative costs associated with the new program include:

Personal Services	\$39.0 FY2026 for one third of a full-time range 16 staff to implement program, develop communication and application materials, provide data research to identify and target Alaskans out of state and administer the program; \$29.6 FY2027 and FY2028 one fourth of a full-time range 16 staff to administer the program and provide required reporting on the program.
Services	\$6.0 FY2026 for promulgating new regulations; \$10.0 FY2028 for required evaluation of the program.
