- Contract management- Manage several reimbursable services agreements with consultants on both rate related and non-rate related matters, providing guidance on agency precedent, passed legislation, ratemaking, and regulations and statutes that guide the regulatory process.

Utility Financial Analyst 4 | Regulatory Commission of Alaska | October 2015 - June 2022

- Assigned as staff on complex revenue requirement studies, cost of service studies, and rate design studies filed by regulated public utilities and pipeline carriers; reviewed financial statements and performed

financial analysis; performed regulatory audits for compliance with applicable statutes and regulations; reviewed general ledgers ensuring costs were prudently incurred; identified rate-making issues; performed on-site audits of a utility's books and records; performed revenue requirement, cost of service, and cost of power adjustment calculations; attended hearings; and prepared fulsome technical memorandum providing guidance and recommendations to the Commissioners.

- Assigned as staff on other filings ranging in complexity, including simplified rate filings, annual pipeline rate filings, gas sales agreements, and gas cost adjustment filings; and prepared fulsome technical memorandum recommending Commission action.
