- Conduct inspections & ensure compliance





- Increased communication


FY22 Vacancies:

DEC FY2024 Operating Budget: Department Overview (in thousands)





DEC FY2024 Operating Budget: Buildings, Maintenance and Operations (in thousands)



Increased Permitting and Testing for the Drinking Water Program and Environmental Health Lab






