## FISCAL NOTE ANALYSIS

STATE OF ALASKA  
2026 LEGISLATIVE SESSION**Analysis**

House Bill 239 amends the classification of criminally negligent homicide in specific circumstances: if a person causes the death of another while operating a motor vehicle and knowingly fails to stop and render aid to a victim, then the criminally negligent homicide would be classified as a Class A felony. Other criminally negligent homicide cases would remain as Class B felonies. Sections 1 and 2. The change in classification is not expected to cause any fiscal impact to the courts.

Section 3 provides that the presumptive sentencing range for the new type of Class A felony created in sections 1 and 2 is seven to 11 years for a first time offender. Section 4 provides that a sentence for a person convicted of the crimes created in sections 1 and 2 must include a consecutive term of imprisonment for each additional crime of failure to stop and render aid under AS 28.35.050 and .060. The court can impose these terms of imprisonment and consecutive sentences when appropriate without fiscal impact.

The court system therefore submits this zero fiscal note.
