I am a mother of two children in the Mat-Su Borough. The day I read about this proposal, my heart sank. A top priority for our state must be the safety and well-being of our children and HB 105 is headed in the exact opposite of that direction.

HB 105 has a number of problematic components, and should not move forward. Firstly, this proposal is sure to endanger the children most in need of it. By requiring an 'opt-in' approach to sex education (including how to identify abuse and consent), guardians who are also abusers can more easily continue to shield their victims from life-saving information. We are also likely to see a great reduction in the number of children learning this critical information, as we know from any other studies on opt-in versus opt-out participation.

Good afternoon Representative Story,

My name is Natalie Troy. I currently work for the Alaska Council of School Administrators but I am writing to you on my own behalf, as a Juneau resident in opposition to the governor's bill HB105.

On gender neutral bathrooms: I grew up in North Carolina from 2009-2018. That state passed a law banning choice around public restrooms and <u>lost an estimated \$3.7 billion</u> according to the Associated Press <u>due to businesses leaving the state in the ensuing controversy</u>. While this bill only impacts schools, the lack of inclusion and acceptance around this idea remains and the cost to districts to construct separate bathrooms would also be something that would need to be attached to this bill or else create an unfunded mandate.

On parents' rights: if a parent wants to be involved in their child's education, they can always speak to the child's teacher or other staff at the school. I call schools across the state every day for work. Schools are busy places focused on the work of educating and sometimes staff can't speak right away, but if someone can't pick up, someone is always willing to take a message. If parents are concerned about their kids' education, they should speak to the people educating their children. Additionally, this committee has entertained a lot of discussion of the importance of education funding going into the classroom. When schools have to spend staff time creating permission slips and tracking down signatures on permission slips to be able to do their job and teach children, that is a waste of state money that should be going not only into the classroom but also to other important school roles like counselor, librarian, maintenance, and nutrition.

On gender, sex, and reproductive changes: students learn about gender the same way they learn about everything: from observing the world around them. From a very young age, we recognize that toys such as trucks and trains are associated more with masculinity and dresses and dolls more with femininity. We interact with children based on those gender roles. Whether you embrace those traditional roles or not, we understand what they are and react positively, negatively, or neutrally based on our own feelings and opinions around gender. Children pick up on those reactions from whoever they are in community with from before they even enter a classroom.

This is similar regarding sex and human reproduction. Children are learning about sex and reproduction in grades K-3 by observing the world around them. Some children even start puberty before the age of 8 in what is known as precocious puberty and experience physical changes around that that other children may pick up on. It's important that kids as young as 6 or 7 have an understanding of the physical changes their peers and siblings are going through as something natural that we should be able to speak to each other about if we choose, not something scary or secretive. Having to sign permission slips to discuss these things in all areas outside of abuse trainings just makes it harder for teachers and other school employees to deliver developmentally appropriate instruction to ensure students' health and well being.

Thank you for your support of public education in the state, Representative Story, and for the insightful and well-researched questions you bring to the full Committee. Thank you also to the full Committee for passing out HB 65.

Members of the House Education Committee;

My name is Linda File. I am testifying today on **House Bill 105, the parental rights bill.** I represent myself and my granddaughter who will begin kindergarten in the fall of 2024.

I am the child of a evangelical minister. Until 2000 my life was defined completely in that context, having been marinated continuously in the dogma recognizable in the parental rights bill now before this Committee.

The arguments contained in this bill comprise the foundational dogma of the evangelical mindset. These statements are the assumptions of those who *know with certainty and assurance that they are right*. Everyone else, particularly the secular public school system is wrong. *And because they are right, they deserve to be dominant*. There is no further discussion for those in this mindset.

Fortunately I had the privilege of attending public school and university where my longing for knowledge was fed and encouraged by many excellent teachers and professors. Libraries were my childhood lifeline and I was lucky to have parents who encouraged reading. Many children in the setting I was raised in are now confined to sectarian schools and religiously dominated home-school settings. This troubles me. I have witnessed several relatives raise their children with no traditional educational input, spending all their years in wholly parental driven home-school scenarios (a niece recently said that they are primarly watching movies as they drive the US in their van).

We now understand that parents do not in fact, own their children. Parental 'rights' do not expunge children of the Privacy Rights recognized in Alaska's Constitution as belonging to ALL the citizens of Alaska. *Children have an inherent right to a quality education, to knowledge, to choice, to personal agency, to not to be held in ownership by any parent*. The parent's role is one of guidance, protection, sustenance, all with compassion and understanding of the child's needs. This is basic human decency.

This bill is unnecessary and completely sectarian in purpose. There are curriculum reviews held regularly for concerned parents to attend in every school district. Principals are always open to hearing from concerned parents (my husband was a public school principal with an open door policy), teachers set aside time to talk to parents. I have never personally heard of a teacher in our District who spent any of their class time touting some personal agenda. To accuse teachers of such is to malign the profession and to speculate nefariously some level of control and manipulation that does not, in fact, exist.

My experience is that those who say they "own" their children are speaking the language of the abuser, whether they intend this or not. In this worldview some parents have caused egregious and unspeakable violations of the child. *Some have no one to turn to.* Projection is often the tool used by authoritarians to attempt to hypocritically accuse others of what they themselves are doing.

Do not subject Alaskans to the copycat "Florida" plan of creating some bogeyman where it does not exist. Do not pass the unnecessary and ill-advised HB 105 out of committee. We are better than this in Alaska.

We complain so much about brain drain and a labor shortage but we cannot do the bare minimum to protect the rights of youth and parents to encourage them to stay here.

Additionally, I'm particularly concerned about the proposed amendment to AS 14.03.016 that would allow parents to remove their children from lessons covering topics related to sexual abuse, sexual assault, and dating violence. Living in a state where sexual violence is incredibly prevalent, it is essential for our students to learn how to protect themselves and when to seek help from a trusted adult. I grew up in the Alaska educational system and did not receive any guidance on the topic of sexual violence, which undoubtedly led to me accepting unhealthy relationship dynamics for far too long. I would not wish that experience on anyone and want to see Alaskan youth equipped with the tools to avoid those situations.

When there are so many other education issues this committee could be addressing, I'm indignant to see time wasted on harmful bills like this one. I encourage the committee to vote no on this bill and move on to more important topics.

I'm writing to express my vehement opposition to HB105. I would call in but I will be at my 2nd job- taken so I can help pay for out of state college for my trans son. College in a state where we feel he can be safe and be himself without constant attacks from people who deny his very existence.

The agony I went through as a parent watching my child struggle with mental health issues in his pre-teen years is reemerging now as fear over his safety in our home state and many parts of the country. It took a long struggle in counseling for him to realize what was so negatively impacting his mental health- the anxiety, depression, intrusive thoughts, self-harm-- all finally began subsiding as he started outing himself as trans and asking us to use his new name and pronouns. My son was always a straight-A student, in gifted, AP, and IB classes. School had always been his favorite place. He buried himself in his schoolwork and maintained his high grades but school became almost unbearable at times. On the surface his school was supportive of LGBTQ kids, including special accomodations for trans kids. However, certain individuals took it upon themselves to not follow the accommodating practices. There were also problems with substitute teachers deadnaming my son due to database issues. Due to COVID concerns, there were multiple substitute teachers daily. So my son's refuge became a dreaded place. Eventually, we were able to work with the principal and other staff to address the problems and life settled into that of a typical HS senior- college exams, applications, essays, and prom rather than anxiety and multiple meetings over names and pronouns. My son is now a pre-med major at a top-tier school on a huge merit award- a testament to his resilience and the support of family, counselors, and many individuals at his school.

To now threaten to take those same supportive systems away from other struggling kids is criminal. My son had the support of his family and could be out at home, however many children do not have that chance. Even my son came out at school first- to friends and teachers before gathering his courage to come out at home. To think that other children would be forcibly outed without their consent before they're ready is appalling. To not provide bathroom facilities for all students to feel safe while taking care of bodily necessities is appalling.

I am unhappily willing to provide more information about our struggles and successes in order to help defeat bills like this.

My name is Cassondra Windwalker, and I am an Alaskan resident living in Anchor Point on the Kenai Peninsula, and I am also a staunch Christian. I am testifying regarding my strong opposition to House Bill 105.

The governor and those who support this bill will turn Alaska into a dystopian state reminiscent of Nazi Germany or modern-day Russia, a world in which teachers become informants and anyone who knows the truth about a person's identity is a potential enemy, holding what in some cases is the very real threat of life-or-death over their head. Republicans once touted themselves as the party of small government and individual liberty, but this bill specifically makes some people's very existence non-permissible, it brings the state into the most intimate of family discussions, and it reaches the government's hands into the panties of our children.

Alaska is the second-worst state in the country for child abuse and the third-worst for domestic abuse. The governor and his supporters want to take the children they are already miserably failing to protect and make their lives immeasurably more dangerous and more wretched. This isn't about protecting children in the least. Children don't need to be protected from knowledge and learning. Teachers don't need to be forced to transform from instructors and mentors into snitches and rats and hoarders of outlawed information. And parents in Alaska definitely don't need more control over their children. With the control they have now, we know that 1 out of every 7 children in Alaska will be sexually abused before they turn twelve. I want a better community for my son, his friends, all my students, and the rest of our Alaskan youth. This bill would be devastatingly destructive for many young people, crushing for our already overburdened educators, and would unempower these same teachers from providing the support and quality education that our students need. My son, currently a senior at West High, has had some incredible impromptu conversations in classes, throughout his years, through our school system, that have helped support him through his most challenging years in ways that he sometimes would not accept from me. Many of these conversations contain nothing extreme in views, but because they relate to gender and sexuality in broad ways, they would need opt in prior notice, according to this recent proposed law (consider that much of a good classic education, like reading Romeo and Juliet, for instance, leads to these kinds of discussions). Our current system provides parents the opportunity to keep up to date on what is happening in their child's education and experience at school. We have many ways for parents to opt out, to limit what their child is exposed to, and, ultimately, there is huge access to homeschool for parents who do not believe in a broad public education for their child. However, the students I most worry about are those who are marginalized, and those without caring parents at home. With stricter limits on what topics can be addressed at school, many of these students will lack basic understanding of health and sexuality, not because their parents' religious or political convictions lead them to opt out, but because they simply won't access the paperwork to opt in. Hi

I am writing today to urge you *not* to support HB105, which *claims* in the summary to be about "parental rights in education" but is clearly designed to punish gay, lesbian, and transgender youth, and the teachers who interact with them. There is abundant evidence that children's sexual orientation and expression are not things that they are socialized into, or can be meaningfully socialized out of. Instead, the end result of laws such as that being proposed here are to out children who are not ready to come out, or putting inappropriate pressure and attention on children who are suffering other kinds of social or emotional difficulties that have nothing to do with sexual orientation or identification. At best, such a law will result in more children becoming homeless (because the parents exercising their rights will kick them out of their homes), or at worst, more children committing suicide because the of the stress of having been outed to disapproving parents over the suspicions of busy-bodies in the schools or teachers fearing fines or loss of employment where normally they would have the good sense to keep their suspicions to themselves.

This law is reckless. This law is stupid. This law will result in significant harm done to children who are having a hard enough time in this society as it is. Neither the rod nor the lash nor prayer will "cure" a child who is transgender or homosexual. All this kind of a bill does is interfere with their education and their lives, and treat them as the *property* of their parents, not people in their own right.

Subject: Testimony against HB 105

Co-Chair Allard, Co-Chair Ruffridge, & Members Himschoot, McCormick, McKay, Prax, & Story of the House Education Committee,

I urge you not to support HB 105.

I understand there is a desperate need to keep parents involved in public schools, under the state budget crisis and trends of homeschooling and the desire for private or charter Christian schools. Scarcity pushes us to sacrifice. But we cannot sacrifice Alaska children so vulnerable to abuse, trans and nonbinary children. Abused and discriminated against children do not have equal opportunity for education. When it comes to equality, it should not be one way at one school or school district and another way somewhere else, because some adults are uninformed about the mistreatment LGBTQ+ children suffer and child abuse generally, or they believe that being transgender is an "ideology." That is not equality.

Dr. Deena Bishop, educational advisor to Governor Dunleavy, called Erin's Law and Bree's Law parental rights legislation. Parental rights are nothing new, she testified on 3/29. I remember the passing of those bills. Erin Merryn doesn't travel the country proposing a "parental rights law," she advocates for children's safety. She proposes that information be given directly to kids, knowing as a CSA survivor that CSA is common and the overwhelming majority of children are hurt by people they know, including manipulative family members. The program protects against sexual abuse by either preventing it or helping abused children disclose. Erin's Law was not introduced with an opt-out originally. It was intended to be mandatory. That was added and Mike Dunleavy, a senator at the time, was proud of that. Not everyone was happy about it. Parental opt-out for a sexual abuse prevention program does not help a child who is, for example, being sexually abused by one parent and neglected by the other. I know this because I am a CSA survivor.

Mandatory reporting, everyone's saved! When I was 12 being sexually abused at home, school staff noticed my depression without reaching out to me, the principal had a meeting with my bystander parent, the principal suggested I get counseling, my parent made excuses to the principal about why I seemed depressed then did nothing, and no further outreach was taken by school staff for me. Then my abusive parents homeschooled me from then on. Homeschooling was just another way to control me and cover up the abuse. My mother, who does love me, failed me, then the school system failed me. I have hoped that since Erin's Law it's better now.

Content warning for psychological abuse associated with child sexual abuse by parent:

My abuser didn't only sexually abuse me. He wanted me to act happy all the time and never disagree with him, to fit his perverted fantasy of a "soul-mate." He wanted my body to look a certain way - my hair length, my body weight. I couldn't be myself. When I didn't act happy enough while he abused me, when I didn't submit as often, he worried that I was "becoming a lesbian." He took over my body and tried to control who I was and how my entire life went. Any of this sound familiar? It's not the same as what gender nonconforming children suffer by rejecting family members, but similar.

No matter how exactly abuse is perpetrated, what's at the core of it is control.

What does this extra vulnerable group of people suffer? Enough about me. This bill specifies gender identity; it most affects people whose gender identities vary. I am sharing the same 2011 study of 6,450 trans and gender nonconforming people that I did in my widespread email, this time focusing not on school experiences but family life - especially pages

88, 94, 100-102. 57% of respondents suffered some form of family rejection (88), at some point in their lives. 40% of respondents said parents or other family members did not speak to them or spend time with them because of who they are (94). Imagine that. Family rejection was associated with 3x the frequency of homelessness and almost double the rate of suicidality than those with accepting families. Family violence was associated with 4x the rate of homelessness and double the rate of suicide attempts (88). There were even more associated negative outcomes over their lifetimes, too. See https://transequality.org/sites/default/files/docs/resources/NTDS Report.pdf

The chance of an affirming family is not enough. There must also be policies on a grander scale as support. The state has a duty and interest in protecting children. By policies I don't mean only training school staff to recognize abuse (especially mental injury, but as it presents in gender nonconforming youth https://dfcs.alaska.gov/ocs/Pages/childrensjustice/reporting/knowmi.aspx) and report it.

But let's imagine that almost every trans, nonbinary and other gender nonconforming child in or that will be in Alaska has an affirming family and that the hypothetical rare abused kids will be immediately protected by school staff and the state because this bill just doesn't hurt these kids because all those loving, informed parents will let their kids be themselves and there's mandatory reporting. But the state won't fully let the kids be themselves.

HB 105 restricts sex education, human reproduction education, or human sexuality education for any child under 4th grade, except for sexual abuse prevention under Erin's Law. Doing this implies the belief that LGBTQ+ children don't exist at even earlier ages than that and the fear they'll be "indoctrinated" or "brainwashed," as if those topics can never be taught age-appropriately. If a younger child shows cross-gendered behaviors and other kids bully them for it, that child might not know how to talk about the bullying and start to feel shame from the bullying, barriers to reporting the abuse. It's the same concept as teaching kids sexual abuse prevention - so they know what abuse is, how to respond to it, and how to disclose it. Kids younger than 4th grade need supportive policies from the state.

Restricting restroom and locker room use to biological sex, therefore banning trans, nonbinary, and other gender nonconforming children from ever using the facilities they identify with under a physical safety and privacy policy implies that these children are inherently a danger to other children, that they are bogeychildren, predators. Or that so many children will pretend to be trans or nonbinary to gain access to others, that these children are mostly frauds. Affirmation has been shown to be healthiest for these children. They need supportive policies for restroom and locker room use in some way. Not their own privacy violated and physical safety endangered by forcing them into facilities of the gender they do not identify with, because they do suffer higher rates of bullying than cisgender children (see https://www.hrc.org/news/new-cdc-data-shows-lgbtq-youth-are-more-likely-to-be-bullied-than-straight-cisgender-youth).

Extra information on child sexual abuse:

2020 reported felony sex offenses in Alaska:

Of victims up to 10 years old, 55% of suspects were family members, the majority.

Of relationships between suspect and victim among family members, the most common was parent-child (including stepchild) at 42%. The secondmost common relationship was "other" (any other than sibling, stepsibling, grandparent) at 33.6%.

Of victims 11 to 17 years old, 28% of suspects were family members.

Of relationships between suspect and victim among family members, the most common was also parent-child at 34.5%. The secondmost common relationship was sibling or stepsibling at 26.4%. Though other was a somewhat close third at 25.5%.

2019 reported felony sex offenses in Alaska:

Of victims up to 10 years old, 54% of suspects were family members, the majority.

Of relationships between suspect and victim among family members, the most common was other at 44.2%. The

secondmost common relationship was parent-child at 29.4%.

Of victims 11 to 17 years old, 33% of suspects were family members.

Of relationships between suspect and victim among family members, the most common was also other at 31.2%. The secondmost common relationship was also parent-child at 29.7%.

Stranger danger was always rare.

My opinions: Younger children are most dependent on their families, so they're easier targets for abusers within families, while older children may have more independence and activities outside the home to expose them to acquaintance abusers.

Legal guardians' attitudes and positions on sex ed or sexual abuse prevention programs can affect children's safety. If the primary caregiver is not the abuser but also bans such education, an abuser who is an extended family member or other family member in the home will benefit from that lack of education by being more likely to successfully manipulate and threaten the child.
