**BILL NO. SB 208**

**Analysis**

This bill authorizes the commissioner to consider leases of state land for agricultural purposes, including land that is not currently classified as agricultural. Conforming regulations will be necessary. The division does not anticipate a fiscal impact in order to implement this bill.
