Tanana Valley State Forest (TVSF)



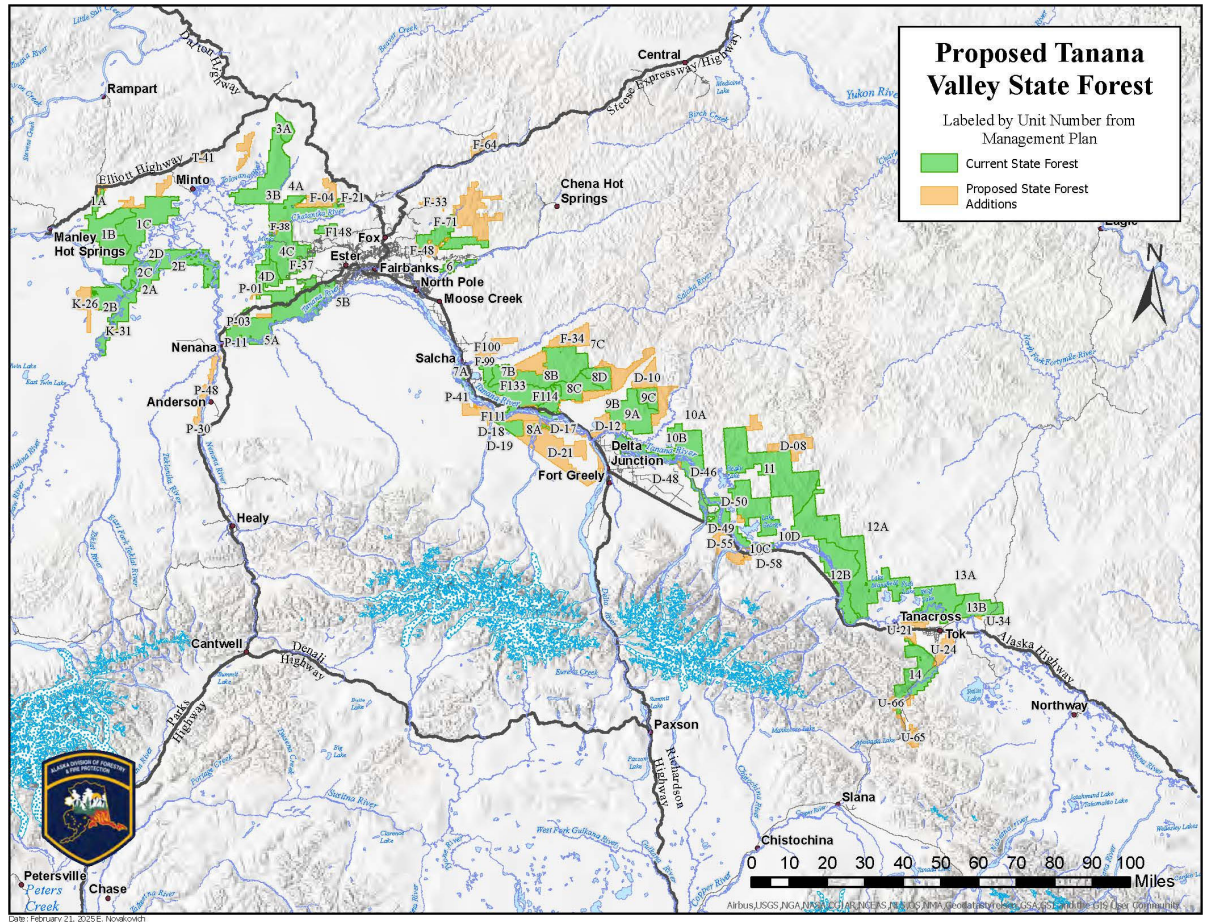
- 1.81 million acre state forest stretching from Manley Hot Springs to Tok
- Established July 1, 1983
- Primary purpose is timber management while allowing other beneficial uses
- Division of Forestry & Fire Protection (DFFP) works closely with Alaska Department of Fish & Game (ADFG) on wildlife habitat and improvements
- Significant forest recreational use includes hunting, trapping, snowmachining, cross country skiing, mountain biking, all-terrain vehicle (ATV) and dirtbike riding, bird watching, floating, camping, shooting, firewood cutting





House Bill 218 – Expanding TVSF

- Proposes adding approximately 600,000 acres to TVSF
- New additions are designated for forestry in the current area plan, some with a secondary designation of habitat
- Additions have been considered for inclusion in TVSF for several years
- DFFP is actively managing some of the additional areas



Why increase TVSF?



- Long-term stewardship of forest resources
- Develop and maintain forest infrastructure
- Commitment to reforestation, water quality and fish habitat protection (FRPA)
- Inclusion of more productive sites in Interior Alaska
- Assurance of timber supply to local industry
- Develop desired habitat conditions
- Protect public access to state lands in perpetuity





State forest expansion process

- DFFP foresters identify productive forests
- Department of Natural Resources' Resource Assessment and Development Section
 - Area Plan update DFFP makes recommendations on forestry designation
 - Make recommendation as addition to state forests – public process
- Issue public notice and hold public meetings on proposed additions to the state forest system
- If the public is supportive, administration can submit legislation and
 - Summary of testimony offered at public hearings
 - Preliminary forest inventory
 - Cost estimate of operational inventory and forest management plan



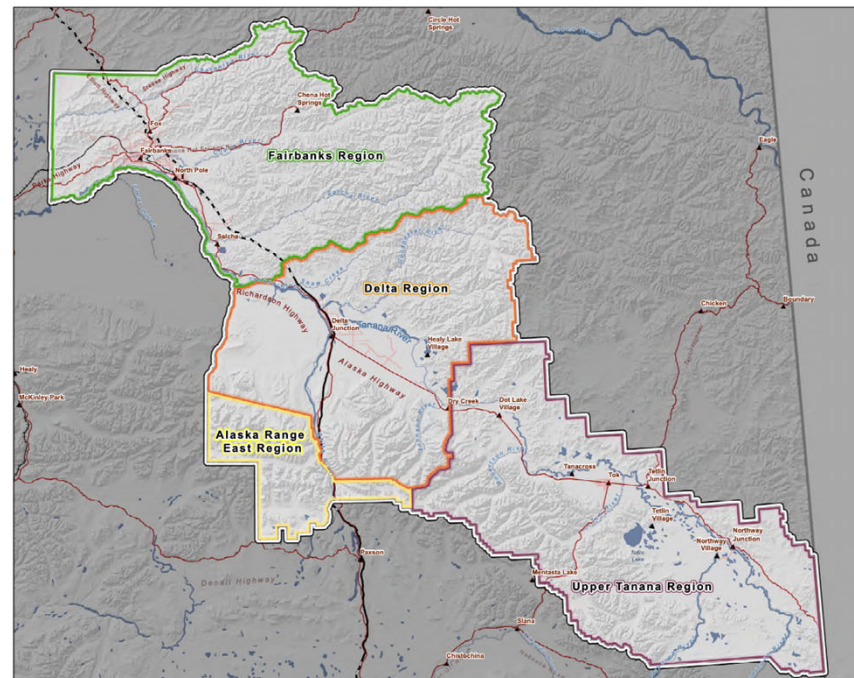
Plan recommendations



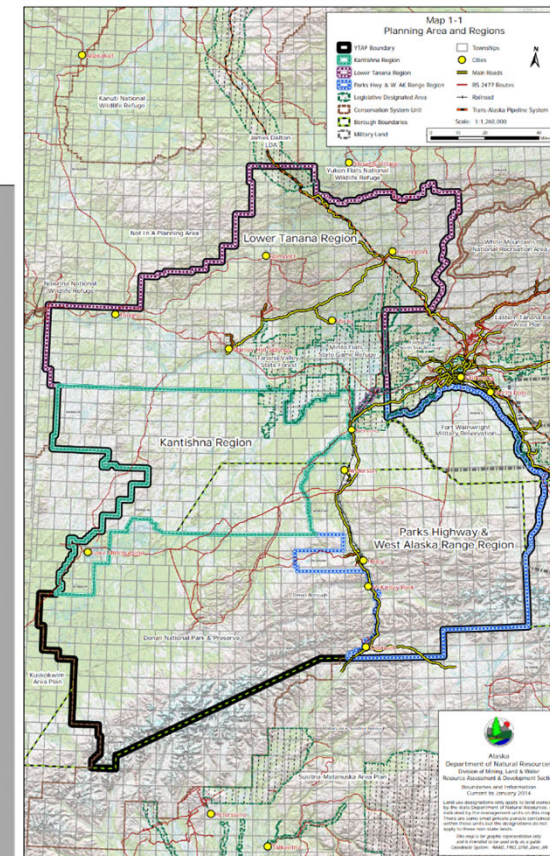
Proposed additions were selected through agency and publicly vetted planning efforts:

- Eastern Tanana Area Plan (ETAP) (2015) - 99,867 acres recommended
- Yukon Tanana Area Plan (YTAP) (2014) - 494,733 acres recommended
- Tanana Valley State Forest Management Plan Revision (2025) - 594,600 acres recommended

- Received **general public support** for TVSF expansion
- Additional **strong public support** for TVSF expansion in recent Yukon Area Plan
- Frequently asked technical questions:
 - Requests to include additional areas, or asking why some areas were not included
 - Requests for emphasis on local use of lumber versus export
 - Interaction with potential carbon projects
 - General questions on planning and land management processes

House Bill 218 Sectional



Section	Page	Description
1	1	Repeals and reenacts AS 41.17.400(d), the legal description of the current TVSF, to include legal description of 43 additional units
2	67	Adds a new subsection to AS 41.17.400 defining “section” and “sections” as both surveyed and surveyed protracted sections
3	67	Adds a new section to uncodified law allowing the Department of Natural Resources to adopt regulations necessary to implement the bill
4	67	Sets an immediate effective date for section 3, authority to adopt regulations
5	67	Sets a July 1, 2025, effective date for sections 1 and 2, expanding the state forest
