FISCAL NOTE ANALYSIS

Analysis

This bill amends AS 14.30 by adding Article 17. Mathematics Education. This article requires implementation of mathematics intervention instruction for grades K-8 and advanced mathematics class sequences for grades 6-8. Additionally, this bill directs the Department of Education and Early Development (DEED) to make a list of instructional materials aligned with the state math content standards and a list of at least one standards-based mathematics assessment that may be used for progress monitoring in mathematics. DEED is further directed to create a credential for teachers who provide instruction in mathematics to grades k-8 and who demonstrate competency in evidence-based mathematics teaching practices.

To support the implementation of this bill, DEED would have the following implementation costs: \$340.0 for a facilitator to support the development of a rubric for mathematics instructional materials and assessments against state standards and in accordance with statute, and to convene a workgroup of 20 Alaska educators to vet materials against this rubric; \$8.0 for staff travel to support the evaluation of mathematics materials and assessments; and \$6.0 for regulation updates.

Additionally, DEED would require staff to support the implementation of the provisions in this bill and ensure effective implementation across districts. This would require (2) new Education Specialist 2 positions at a cost of \$302.6 (salaries) and \$45.6 (chargebacks) annually, with a \$10.0 year-one cost for supplies and equipment. These positions would support both the initial implementation and ongoing responsibilities associated with this work. Initial efforts would include coordinating procurement and vendor support, as well as developing the rubrics and tools used to evaluate instructional materials and assessments. Ongoing responsibilities would include providing sustained district support to implement the requirements, supporting understanding of standards and alignment expectations, managing and maintaining approved lists of instructional materials, assessments, and credential-aligned coursework, and reviewing submissions for approval. Similar to the Alaska Reads Act, maintaining these approval lists requires continuous review, validation, and communication with districts and providers, necessitating dedicated staff to ensure timely and consistent statewide implementation.

To ensure all materials are current, DEED would conduct a refresh of the vetted list of instructional materials and assessments in year five. This would incur two one time costs: \$200.0 for a facilitator to support the update of the rubric and an evaluation workgroup of 20 Alaska educators; \$8.0 for staff travel to support the evaluation workgroup and update process.
