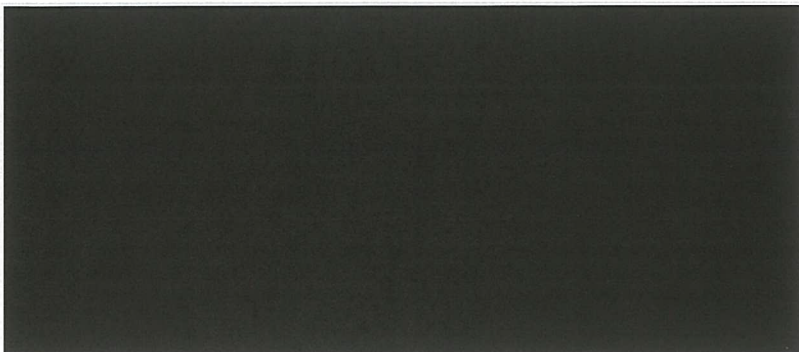

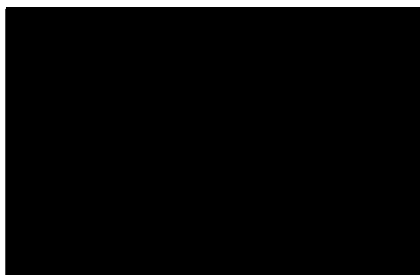

Honorable representatives:

Children are a gift to parents, from God.

God has given parents the primary responsibility for instructing their children in all kinds of practical, moral and spiritual matters.

In our state, parents may choose to delegate some of the practical instruction (i.e., Reading, Writing, Arithmetic, and Citizenship) to the public school system. However, in recent years, many parents have chosen home school or private schools, because they perceive that the public school system is increasingly over-reaching its area of responsibility.

Although many parents could do a better job at instructing their children concerning the sexual facts of life, and the appropriate way of life concerning those facts, that responsibility rightly belongs to the parents, unless and until they purposely delegate it to the school system.

H.B. 105 recognizes this parental responsibility, and requires definite parental approval before allowing a public school teacher to teach their children concerning matters related to human sexuality and reproduction.

H.B. 105 also recognizes that the parents have the first responsibility for the physical and mental well-being of their children. Good parents who become aware of a child's injury or serious illness will seek appropriate help, through the family physician or hospital of their choosing. With the guidance of the medical experts, such parents will decide the best course of treatment for that child. Such decisions may be very difficult. But for the well-being of their loved child, parents will do the research and seek the best resolution.

Parents naturally have a similar role in regard to a child who displays some form of psychiatric difficulty, whether it be autism, anger management, sexual dysphoria, or trans-gender ideology. Such issues must not be hidden from parents. When parents are aware that their child is struggling with sexual issues, they can seek appropriate psychological and spiritual counsel, to assist their offspring in the transition between childhood and adulthood.

Without parental approval, the school system cannot administer an aspirin to a child. A teacher certainly cannot authorize a child's appendectomy. Such decisions rightfully belong to the child's parents.

Likewise, no teacher or school system can rightfully usurp the parental role regarding their child's sexuality. Parents need to be involved in any discussions regarding the use of contraceptives, or the consideration of an abortion or gender change.

Please Support H.B. 105. It is the right thing to do.

As spelled out by the Alaska Beacon on March 8, 2023, I support all of these.

- Parents would be required to provide written permission for their students to participate in sex-ed classes. Currently, parents are required to receive written notice before those classes and may opt their children out of the class.

# COMPREHENSIVE SEX EDUCATION: THE HARMFUL EFFECTS ON CHILDREN



## **1. SEXUALIZES CHILDREN**

Normalizes child sex or desensitizes children to sexual things. May give examples of children having sex or imply many of their peers are sexually active. May glamorize sex, use graphic materials, teach explicit sexual vocabulary, or encourage discussion of sexual experiences, attractions, fantasies or desires.

## **2. TEACHES CHILDREN TO CONSENT TO SEX**

May teach children how to negotiate sexual encounters or how to ask for or get "consent" from other children to engage in sexual acts with them.

## **3. NORMALIZES ANAL & ORAL SEX**

Introduces these high-risk sexual behaviors to children and may normalize them. May omit vital medical facts, such as the extremely high STI rates (i.e., HIV and HPV) and oral and anal cancer rates associated with these risky sex acts.

## **4. PROMOTES HOMOSEXUAL / BISEXUAL BEHAVIOR**

Promotes acceptance of and/or exploration of diverse sexual orientations, sometimes in violation of state education laws. May omit vital health information and/or may provide medically inaccurate information about homosexuality or homosexual sex.

## **5. TEACHES CHILDREN SEXUAL PLEASURE**

Teaches children about sexual pleasure. May tell them they are entitled to or have a "right" to sexual pleasure or encourage children to seek out sexual pleasure.

## **6. PROMOTES SOLO OR MUTUAL MASTURBATION**

While masturbation can be part of normal child development, encourages masturbation at young ages, making children more vulnerable to pornography use, sexual addictions or sexual exploitation. May describe masturbation or provide instruction on how to masturbate. May encourage children to engage in mutual masturbation.
