SUBJ: Ketchikan Office Space and LIO Lease Extension

The lease extension agreement between the Ketchikan Gateway Borough and the Legislative Affairs Agency (LAA) for office space and the LIO in Ketchikan, is for a five-year term that began March 1, 2022. The lease extension was authorized by a previous Legislative Council Chair and was under the \$50,000 threshold thus did not require action by the Committee.

In Fiscal Year 2024, the annual cost of this lease extension will exceed \$50,000 with CPI-U adjustments that take effect July 1. LAA requests approval to continue the initial lease extension through February 28, 2027; after which there will be five (5) one-year renewal options of the lease remaining.

Continuing this lease extension exceeds \$50,000 in one fiscal year; therefore, Legislative Council approval is required.
