## FISCAL NOTE ANALYSIS

### Analysis

This legislation enacts four interstate licensure compacts: the Interstate Medical Licensure Compact (IMLC) for physicians and osteopathic physicians; the PA Licensure Compact for physician assistants; the Psychology Interjurisdictional Compact (PSYPACT) for psychologists; and the Recognition of Emergency Medical Services (EMS) Personnel Licensure Interstate Compact Act (REPLICA) for emergency medical technicians, advanced emergency medical technicians, and paramedics.

EMS licensure is overseen by the Department of Health. Alaska has already aligned statutes to allow REPLICA participation by moving licensure of mobile intensive care paramedics from the Medical Board to the Department of Health.

Alaska must enact these four compacts, along with the Nurse Licensure Compact (NLC), to meet the federal commitments tied to the state's \$272 million Rural Health Transformation Program (RHTP) award. Failure to pass and implement all five compacts within the next two years will result in a loss of funds. Because the division will need time to implement these compacts, passage this year is essential to meet the federal deadline.

This legislation also amends the scope of practice and collaborative practice agreement requirements for physician assistants (PAs), allows PAs to work without collaborative practice agreements in certain circumstances, and establishes the qualifications for PA licensure in statute.

If the bill passes, multiple regulations projects will occur. However, the cost of these regulations projects can be absorbed within the existing authority and will likely be combined with other regulations projects.

*Professional licensing programs within the Division of Corporations, Business and Professional Licensing are funded by Receipt Supported Services, fund source 1156 Rcpt Svcs (DGF). Per AS 08.01.065, licensing fees for each occupation are set so the total amount of revenue collected approximately equals the occupation's actual regulatory costs.*
