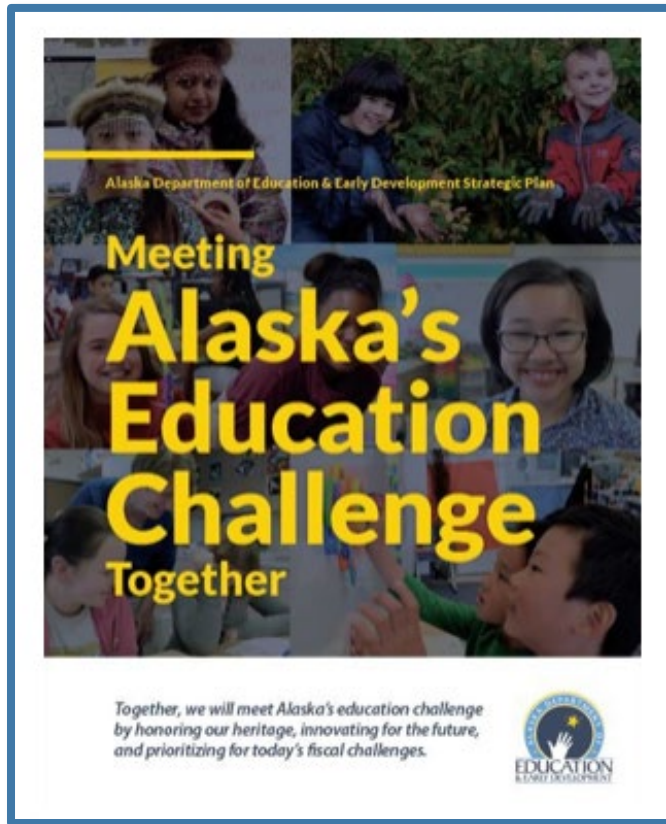

4. Prepare, attract, and retain effective education professionals.
5. Improve the safety and well-being of students through school partnerships with families, communities, and tribes.

# A Little Territorial History

- Cities in the Territory were required to provide public school services
  - “Every city shall constitute a school district and ... the [city shall] provide the [school district] with ... the necessary funds to maintain public schools ...”
    - City School Boards had the power to tax to raise revenue for the schools (ACLA 37-3-41; 37-3-25)
    - The Territory *could* refund to the city a percentage of school costs (ACLA 37-3-61-62)
- Education services in non-organized areas were provided by the U.S. Bureau of Indian Affairs (BIA)

# Bureau of Indian Affairs

- After statehood Alaska and BIA coordinated on education
  - Plan for eventual integration in Alaska system, needed federal funding support
- BIA operated 150+ elementary school facilities
- Schools transferred to State and other entities (municipalities, native corporations) between 1960 and 1989
- Federal law passed requiring no BIA-funded schools after June 30, 1985

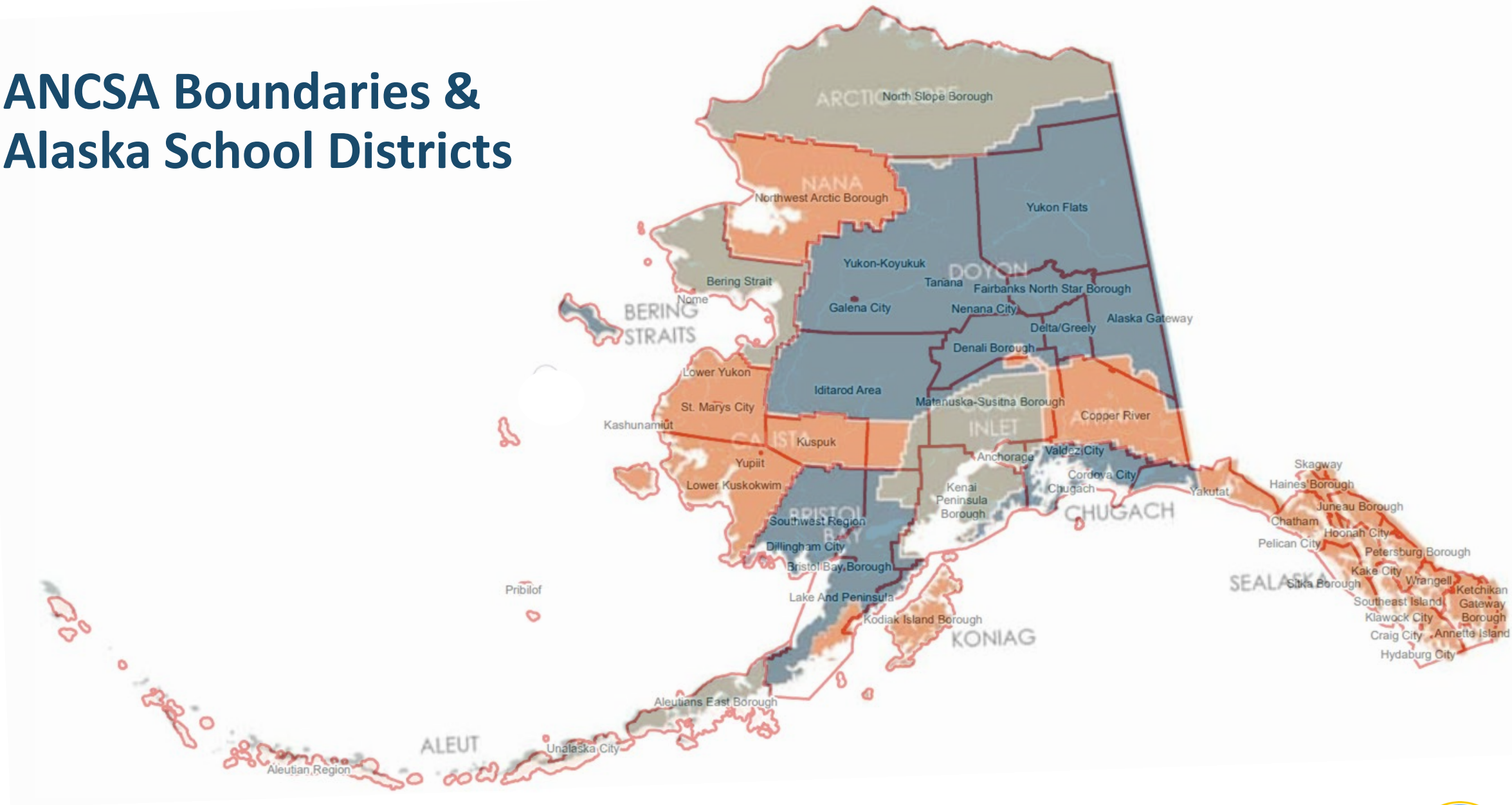
# Statutory Responsibilities

- Legislature is responsible for providing public education
  - Sits as the assembly for the unorganized borough
- AS 14.12.010 establishes school districts
  - The area outside organized boroughs and outside home rule and first-class cities is divided into regional educational attendance areas.
- Legislature delegates certain responsibilities to school districts / school boards
  - AS 14.08. Education in the Unorganized Borough
    - Establish REAA boundaries, election of regional school board, powers, duties
- DEED exercises general supervision over public schools (AS 14.07.020(1))

# Establishment of Regional Educational Attendance Areas

- AS 14.08.031. Regional educational attendance areas
- DCCED, DEED, and local communities divide the unorganized borough into educational service areas using boundaries of ANSCA regional corporations (unless by referendum a community votes to merge with another community contiguous to it)
  - These are the regional educational attendance areas (REAs)
- Each REA shall contain an integrated socio-economic, linguistically and culturally homogeneous area, with consideration for transportation and communication between communities
- Federal Transfer REAs authorized by the Legislature in 1985 allowed specific independent communities to form an REA. Akiak, Akiachak, Tuluksuk voted to form Yupiit REA; Chevak voted to form Kashunamiut

# ANCSA Boundaries & Alaska School Districts

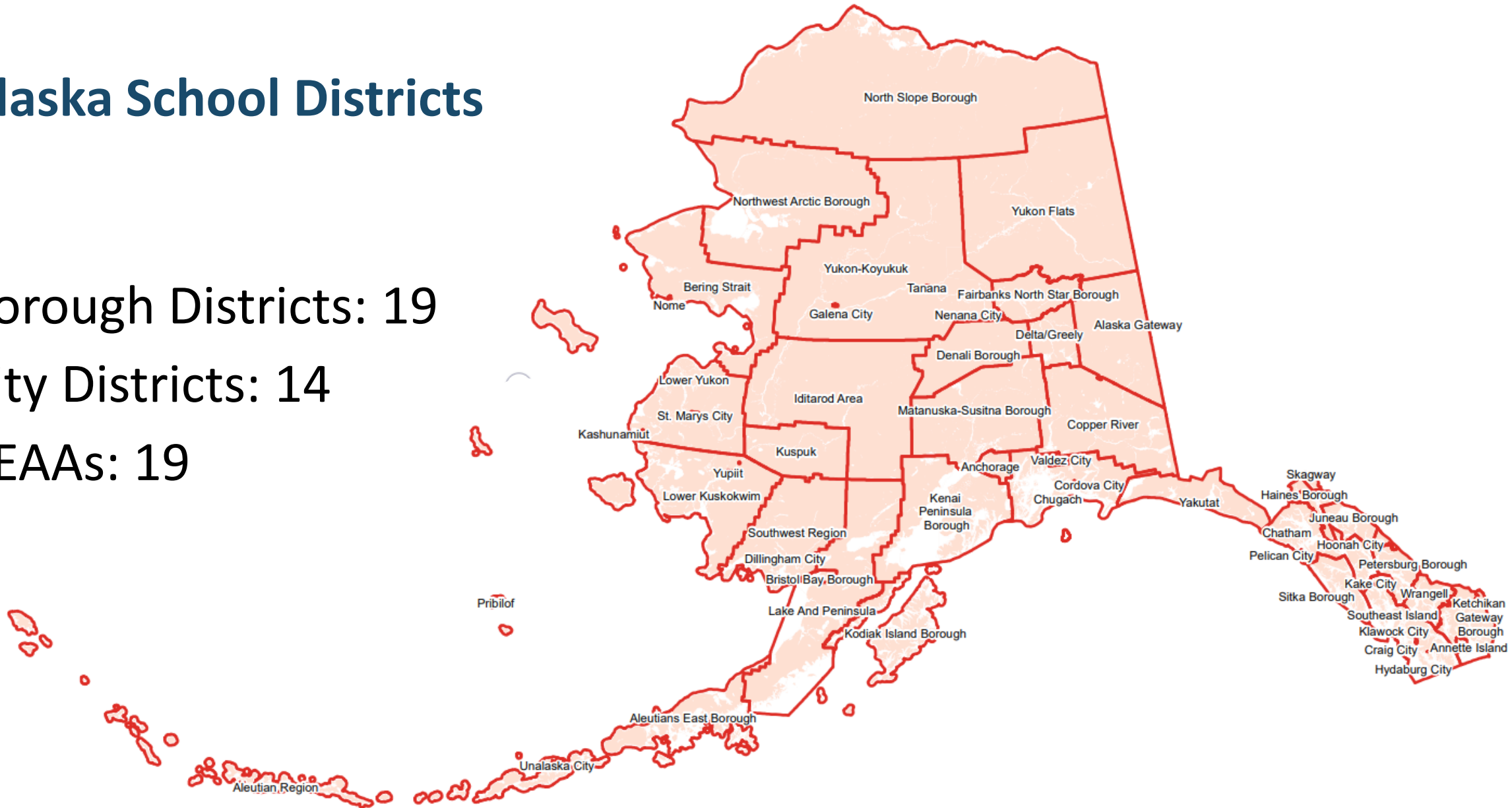

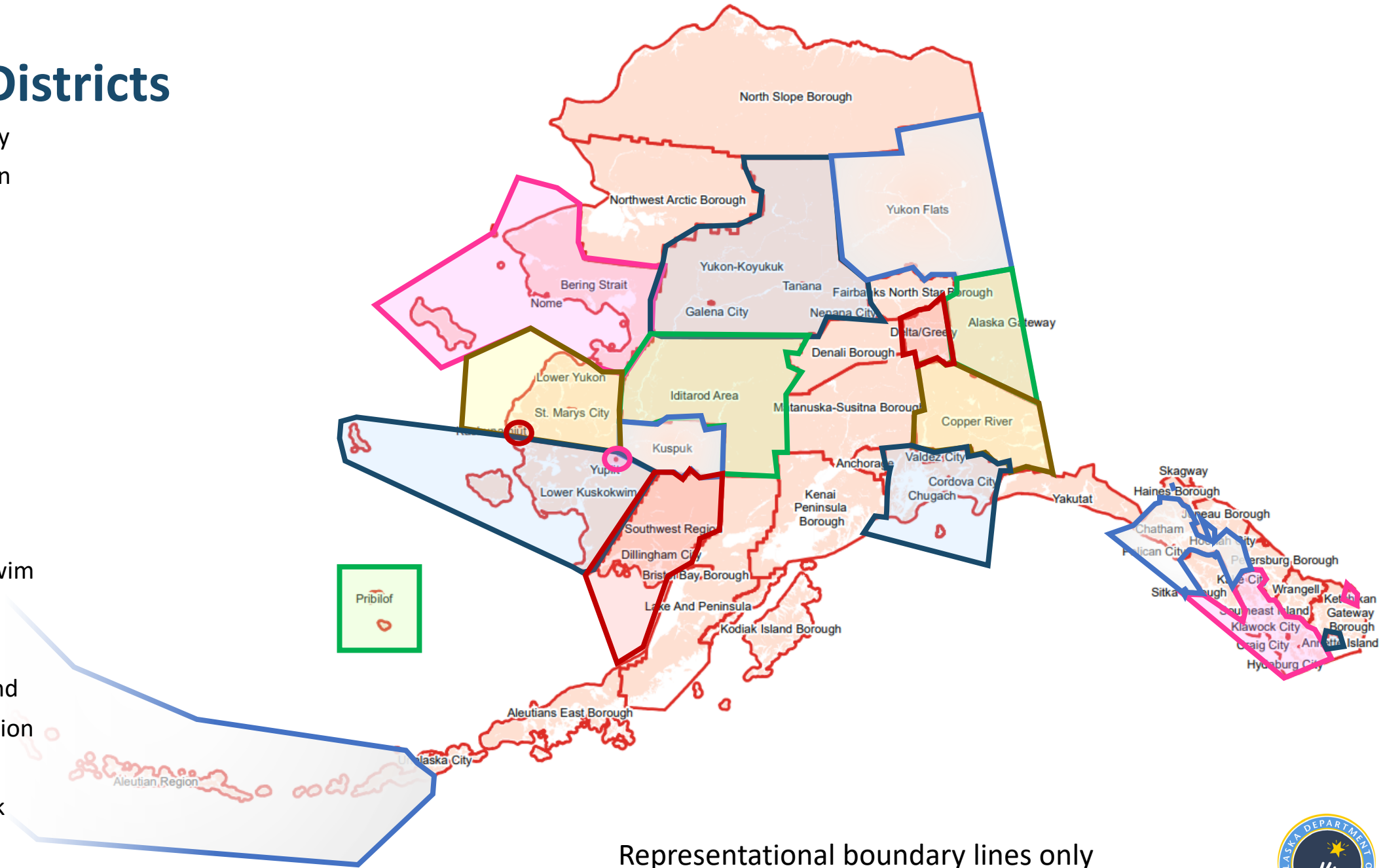

# School Board Elections

- REAA elections are administered by the Division of Elections
- REAA School Boards consist of 5-11 members; same terms and qualifications as municipal boards
- REAA's are typically divided into sections for purposes of electing a resident within each area

# School Board Duties

- Hires and evaluates superintendent
- Adopts and monitors budget; ensures audit occurs
- Sets and updates policies
  - Student learning
  - Personnel
  - Facilities care and maintenance

# Funding REAAs

## Operating Funding

- State aid for school districts (foundation funding): adjusted average daily membership (ADM) multiplied by base student allocation (BSA)
- Federal and other grant sources

## Capital Funding

- AS 14.11 grants (School Construction and Major Maintenance)
- Federal and other grant sources

# Average Basic Need per ADM

## Basic Need

Adjusted for school size factors

- Smaller ADM schools receive more per student funding
- More small schools in REAAs

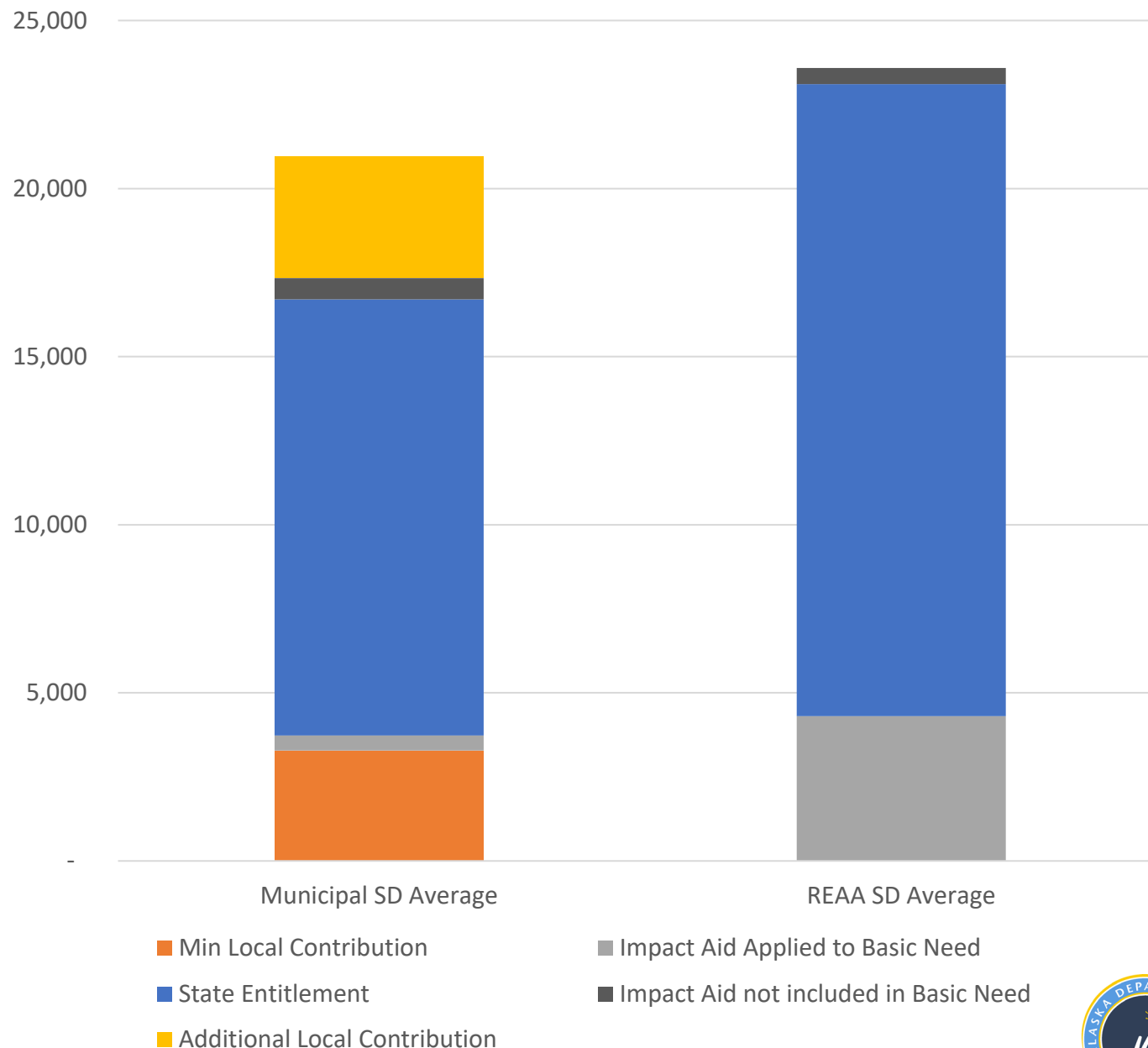
District cost factors

Municipal average cost factor: 1.365  
 REAA average cost factor: 1.667

Correspondence ADM receives less per student funding

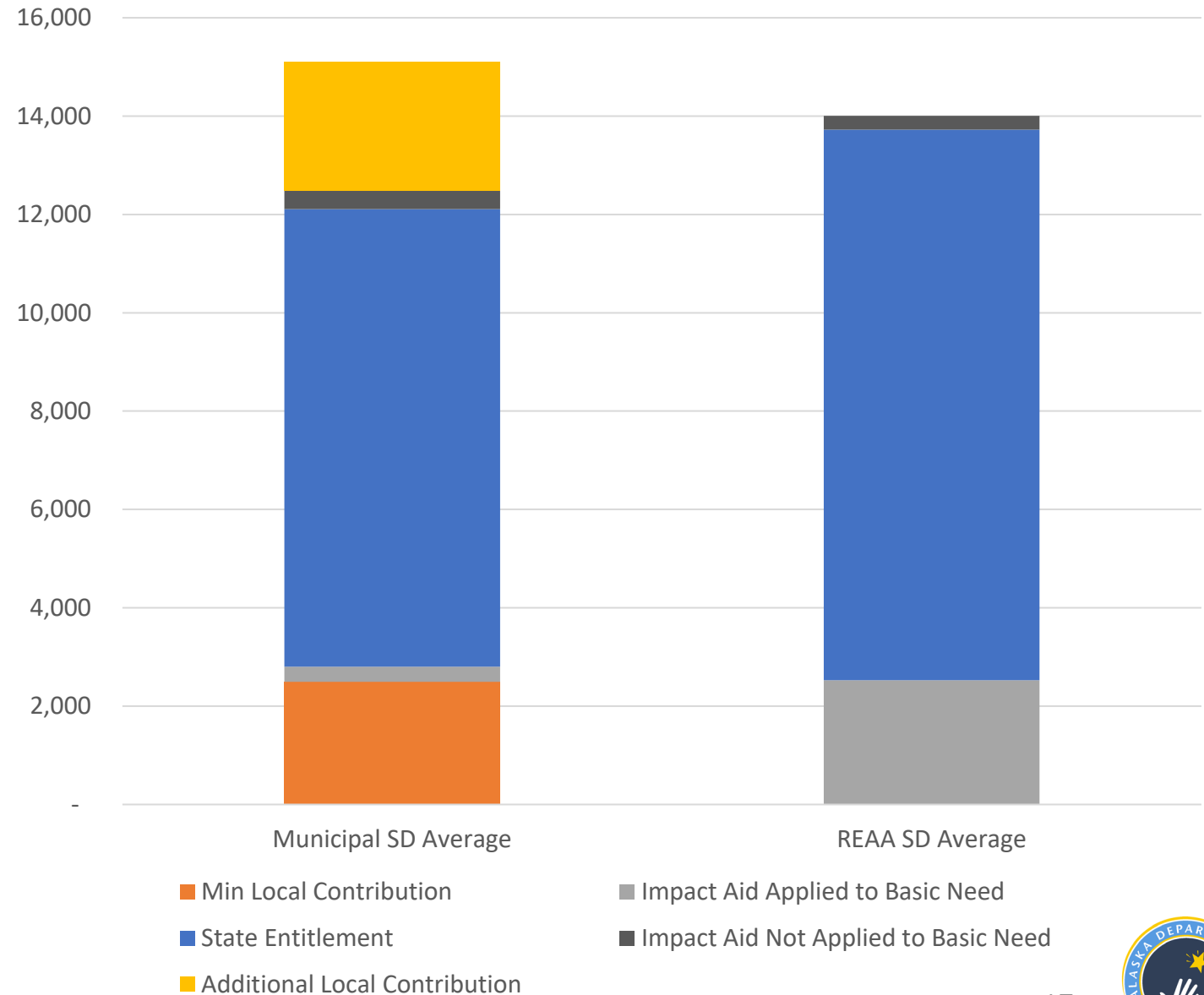
- More correspondence in municipal districts

# Facility Ownership

- AS 14.08.151 provides that ownership of land and buildings is with the state, and REAAs are given use permits
  - Also allows school board to request title from the state
- Eight REAAs have title to all properties; remaining 11 REAAs are a mix of district-owned or -leased and state-owned or -leased.

# Use Permits

Use permit is required for all districts utilizing a state-owned property

Use permit requirements established in 4 AAC 31.090, superseded previously issued use permit

- Property's primary purpose is education
- Maintain property in good repair and operating condition; capital improvements responsibility of the state
- Maintain insurance: property loss, worker's compensation, general liability
- Notify DEED regarding hazardous substance damage or lawsuits resulting from use of property
- District may request termination for a property, if no longer needed to provide education in a community

# Capital Funding

- Capital funding through competitive grant application: School Construction Grant Fund, Major Maintenance Grant Fund, and the REAA Fund
- 4 AAC 31.090(a)(4) “to the extent provided by law, financing for capital improvement projects remains the responsibility of the state”
- State-funded projects through Alaska Housing Finance Corporation (teacher housing); Alaska Department of Environmental Conservation (e.g., Village Safe Water), etc.
- Federal grants, including Impact Aid Construction funds
