FISCAL NOTE ANALYSIS

STATE OF ALASKA
2026 LEGISLATIVE SESSION

Analysis

This bill establishes a new veterans sentencing program that is unlike existing sentencing mechanisms in Alaska law. The court is required to inform defendants of the program, and the prosecution may use state and federal databases to verify a person’s veteran status. If an eligible veteran is convicted of or pleads guilty to a misdemeanor offense, the court may proceed under the program, which may include probation, evidence-based treatment, and a case plan. Upon successful completion, the court may set aside or reduce the conviction, or expunge it from the veteran’s record. Eligibility turns on whether there are one or more indicators of mental or physical symptoms of a condition created by military service that may have contributed to the offense. The bill does not clearly define how eligibility is established, what evidentiary standards apply, or how completion of treatment is measured.

Because this is a new and undefined sentencing structure, the division expects significant litigation regarding whether a defendant qualifies for the program, whether the defendant has successfully completed treatment, and which party bears the burden of proof on eligibility and compliance. These disputes are likely to generate hearings, motion practice, and appeals beyond those associated with typical misdemeanor sentencing. The division anticipates the need for at least one full-time prosecutor to handle this case type, litigate contested eligibility and compliance issues, and serve as a subject-matter advisor to prosecutors statewide. An additional paralegal will be required to manage increased victim contact and case coordination resulting from the anticipated litigation. This estimate is conservative, as the division cannot predict how many defendants will qualify for or seek entry into the program.
