FOR AN ACT ENTITLED

1 **"An Act relating to state refuges and fish and game critical habitat areas; relating to the**
2 **boundaries of the Jonesville Public Use Area; and providing for an effective date."**

3 **BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:**
