Communities with NO Access to DMV Services – DMV Rural Travel Program

Travel Commitments of Community

- Identifying, verifying and document gathering and vetting of all potential customers; working hand in hand with DMV
- Securing a facility with an internet connection to process REAL ID transactions
- Storing any Division material or equipment that is sent in advance in a temperature-controlled environment that is secure

Financial Commitments of Community

- Round trip airline reservations including luggage costs for DMV Employees
 - Including large suitcase holding camera, processing station, etc.
- Hotel/lodging accommodations for DMV Employees
- Transportation expenses, including, but not limited to rental cars, airport parking, and taxi fares
- Food for DMV employees or per diem of traveling employees

**The DMV does not have a designated travel budget for this purpose, nor does it have dedicated travel personnel. To facilitate rural travel, employees must be temporarily reassigned from public service stations, which can impact service availability & wait times at those locations.*
