Chair and Members of the Finance Committee,

My name is Jenalie Tao, and I am a caregiver here in Alaska, advocating for the passage of HB 96 and SB 154, and for increased funding in the state budget for home care and PCA services. I am in Juneau to speak for caregivers, seniors, people with disabilities, and the families who depend on us every day.

Alaska is facing a severe caregiving workforce crisis. Low wages, outdated Medicaid rates, and chronic underfunding have pushed many caregivers out of the field. This leaves elders and people with disabilities without the stable, consistent care they need to remain safely in their homes and communities.

HB 96 and SB 154 are essential because they create the Home Care Employment Standards Advisory Board, finally giving caregivers, seniors, disability advocates, and providers a voice in the Medicaid rate-setting process. For the first time, the people who provide hands-on care will be included in decisions that directly affect wages, workforce stability, and client safety.

However, these bills cannot succeed without increased funding in the state budget. Agencies cannot recruit or retain workers without competitive wages. Clients cannot receive reliable care when the workforce is unstable. Without investment, Alaska risks deeper shortages, more institutionalization, and higher long-term costs to the state.

I respectfully ask the Finance Committee to:

- Increase Medicaid funding for home care and PCA services so agencies can pay competitive wages.
- Support HB 96 and SB 154 to ensure caregivers have a voice in rate-setting.
- Protect seniors and people with disabilities by stabilizing the workforce that keeps them safe at home.
- Ensure transparency and accountability so public dollars reach the workers providing the care.

Caregivers are the backbone of Alaska's long-term care system. We love our work, but love alone cannot support our families. Investing in caregivers is investing in the safety, dignity, and independence of the people we serve.

Thank you for your time and for considering the needs of Alaska's caregiving workforce.

my name is Tonda, I am from the Mat-su Valley and have been a caregiver for 23 years. I became a caregiver to be able to appropriately care for a family member. but I truly believe this is what I was created to do.

Alaska's Health care system is failing. Due to stagnant wages & a lack of oversight, our most vulnerable citizens are suffering inadequate care: It's going w/o meals, essential hygiene/showers & Basic medical monitoring. Worker Burnout: HC workers are pushed to the max because agencies cannot recruit new HC workers or pay necessary OT. Safety Risks: This neglect leads to preventable falls, malnutrition, ~~infect~~ infections and sadly Depression & Suicides.

The current model is fiscally irresponsible: A nursing home bed in AK costs \$30,000+ per month. Home care is a fraction of that cost yet we continue to lose ~~caregivers~~ ^{caregivers} to entry level Retail jobs that pay more. ^{workforce}

The Average caregiver wages (\$16-\$19/hr) do not meet the \$3,000+ monthly cost of living in AK.

Tax payer dollars allocated by Congress are not reaching the healthcare workers. It's being lost in Administrative overhead. If we don't ~~pay more~~ fund ~~the~~ ^{caregivers} ~~workers~~ now, The state will pay ^{10x} more later in ER visits & institutionalizations. ~~later~~

I respectfully Ask/urge The legislature to take the following Actions...

- Allocate more money in the 2026 Budget for ~~health care workers~~ ^{caregivers} to receive an ~~AP~~ Appropriate Living Wage.
- Pass HB 96 & SB 154 To give ~~caregivers~~ ^{caregivers} a voice and makes sure we get a fair share of money to care for ourselves and our families.

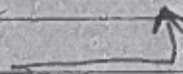

Hello! My name is Garnet Morey, I am a caregiver in Nikolaevsk and Anchor Point, Alaska, for 3 years now. One client is a Veteran with PTSD, and my other is a non-verbal, wild-child ~~teenager~~ teenager that I've helped since 2019, being his Special Education teacher. My Veteran gets me for 11 hours a week. She needs more hours, I never get to finish the needed cleaning. I work OFF the CLOCK TOO MUCH. I do sleep overs when she needs me, and it's my own time, no pay, because getting the hours a client TRULY needs... IS HARD. She is often chair-bound and cannot move without

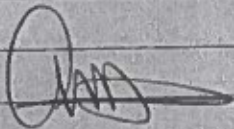
