FOR AN ACT ENTITLED

1 "An Act relating to organized theft; relating to theft of medical records and medical

2 information; relating to mail theft; and providing for an effective date."

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

4 * Section 1. AS 11.46 is amended by adding a new section to read:

5 Sec. 11.46.115. Organized theft. (a) A person commits the crime of organized 6 theft if the person individually or jointly violates AS 11.46.120 or 11.46.130 in 7 coordination with a group of three or more persons who have committed or attempted 8 to commit two or more violations of AS 11.46.120 or 11.46.130 for the benefit of, at 9 the direction of, or in association with the group. 10 (b) Organized theft is a class A felony.
