MISSION AND PURPOSE AIDEA


To promote, develop, and advance the creation of jobs and economic development in Alaska by providing various means of financing and investment. (AS 44.88.070)



ABOUT AIDEA

- The Alaska Industrial Development and Export Authority (AIDEA) was created as a public corporation of the State of Alaska (SOA) (AS 44.88.020)
- AIDEA serves as a catalyst for economic development, with a track record for success, by utilizing a variety of financial tools to finance Alaskan businesses and infrastructure development projects
- AIDEA is financially self-sustaining; pays for costs authorized under its authorized operating budget using AIDEA Receipts (AS 44.88.190(b) and 44.88.205)
- AIDEA provides an annual dividend payment to the SOA (AS 44.88.088)
- Including the \$20 million dividend to be paid in FY 2026, AIDEA will provide more than \$495 million in total dividends to SOA since the first dividend was issued in 1997


AIDEA Bonds and Loans Funded in whole numbers
