ADD INTENT:

It is the intent of the legislature that the department increase the daily rate for General Relief/Temporary Assisted Living from \$104.30 to \$169.48 to reflect the real costs of General

Relief/Temporary Assisted Living in assisted living homes.

**EXPLANATION:** 

In FY23, the daily rate of General Relief increased by inflation from \$70 to \$104.30 on July 1, 2022. However, the inflationadjusted rate is below the actual costs of General Relief. The \$6,444.9 increment to the Governor's FY24 proposed funds for General Relief/Temporary Assisted Living increases the total funds to \$16,839, resulting in a daily rate of \$169.48.

This appropriation would provide funding for an additional study focused on the true cost of child care, as experienced by parents. The study should include detailed information on the share of parents who pay for child care exclusively through private means, and also outline information on parents who receive state, local, or Tribal government subsidies. Information about employer-

assistance child care programs is also requested.

**EXPLANATION:** 

This amendment proposal expands agency capacity for outreach for Alaska Infant Learning Program. Early intervention has proven life-long benefits to program recipients, however program participation rates remain low. Children from birth to 3 years are in the most important developmental phase of their lives.

Alaska's Infant Learning Program offers developmental screening & evaluation, hearing & vision screening, family services coordination, early educational services, social services such as support or play groups, and developmental services such as therapies, physical occupation, and speech language therapy.

The ILP program will not deny services for inability to pay. With increased funding, Department of Health may expand outreach to families with children with developmental disability, with the goal of supporting early intervention efforts to bring Alaska up to the national average for outcomes for young children with

developmental disabilities.

This amendment proposal provides an additional increment to this allocation to further increase community grants over their FY 2023 amount. Community grants serve older Alaskans from Utqiagvik to Ketchikan. They enable seniors to remain independent and to live in the community of their choice. Community grants may be used to cover up to 1/3 in total eligible project costs.

This program has dwindled in scale after nearly a decade of flat funding and the ravages of inflation. The number of seniors in Alaska increases by more than 10% each year, growing the number of recipients seeking services and increasing costs over time. In 2022, Alaskans aged 60+ (147,504) represent more than 20% of the State's total population (736,556).

An additional FY 2024 increment over the Governor's amended budget request will ensure the program keeps up with growing need in the coming fiscal year.

state.

**EXPLANATION:** 

Federal relief funding injected the child care sector with millions of dollars, helping keep child care providers' doors open. Final phase of the child care stabilization grant program ends March 2023. The federal relief funds have not solved the long-term challenge: how to provide quality services and pay workers a competitive wage while keeping prices affordable.

Until the legislature takes policy action to increase worker pay and stabilize parent costs in the child care sector, the state must invest its resources to stabilize the sector. Components of this targeted investment to include: working parent support, child care workforce support, and child care program support. Reinstate covering child care co-pays for families using child care assistance; and provide child care assistance to the child care workforce regardless of income. Invest in supplemental wages to individual early educators. Continue support to licensed child care programs to ensure Alaska's workforce has access to child care.
