I believe that the current interpretation of the EBEA undermines the BoF process by both prohibiting those with the most knowledge and expertise of BoF issues from actively and meaningfully contributing to strengthening Alaska's fisheries laws and policies and by also discouraging well qualified applicants from submitting their names for consideration to serve on the BoF. Additionally, because of its size, the BoF roster of a seven member makeup is especially vulnerable to lacking in informed and insightful discussions if even one member is recused.
