Dear Community and Regional Affairs Alaska House,

I am writing as a concerned Alaskan and an ally to the LGBTQ2 community to urge members to support House Bill 99.

It can go without saying that discrimination has very real impacts on LGBTQ2 youth, adults, and elders within the state of Alaska. According to the 2020 Alaskan LGBTQ+ Health Needs Assessment Survey, 85% of Alaskan LGBTQ2 adults have reported experiencing a mental health disorder. According to the Trevor Project, more than half of all Alaskan LGBTQ2 youth reported experiencing depression, and almost three-fourths experiencing significant anxiety. Alaska Native LGBTQ2 youth, in particular, report more instances of harassment and discrimination due to being LGBTQ2, furthering already-abhorrent mental health statistics and making them 2.5 times more likely to attempt suicide than non-Native LGBTQ2 peers.

Living in a state where there are no laws prohibiting discrimination against LGBTQ2 Alaskans—in fact, where protections that once existed for housing, finance, and more, were recently rolled back—undoubtedly contributes to the harmful mental health statistics being faced by LGBTQ2 Alaskans. This should not be okay by any standards, and Alaskans all over the state are asking for action and progress. As a lesbian and an Alaskan resident, this issue is personal for me.

The 33rd Legislature has a unique opportunity to build a brighter and more equitable future where ALL Alaskans can thrive without the ever-present threat of discrimination. I urge you to take bold leadership and support passage of House Bill 99, to build a better Alaska for tomorrow.
