Many years I invited someone from STAR to do a presentation appropriate to the age of my young students so that they could learn how to keep their bodies safe. The school nurse also did lessons. Parents were always informed ahead of time and in 20 years no one ever objected. We all have the same goal of keeping our children safe.

We also for many years used an anti-bullying curriculum. This bill strikes me as a bully. This bill targets a segment of our population and leaves them vulnerable to bullying and discrimination.

In addition, it is damaging fiscally as well as socially. People who may have thought of relocating here, will change their minds and many others may leave. We are already in a population and workforce crisis.



Moral panic is defined by the Oxford English Dictionary as "A mass movement based on the false or exaggerated perception that some cultural behavior or group of people is dangerously deviant and poses a threat to society's values and interests." The aim of moral panic is to trigger a reactive response from the public, often promoting legal actions and calls to arms that radically dwarf any actual threat of harm or concern.

The response of the governor, Mike Dunleavy, to introduce education reforms with HB 105 that explicitly call out, "parents to sign off when a child asks to change their name or pronouns and require children to use locker rooms and restrooms according to their biological sex," is a perfect example of the application of moral panic for political gain. Similarly egregious were the reform measures introduced in the Mat-Su Valley last year restricting the participation of children in athletics to their "biological sex." Now, this same measure is under consideration from the Alaska State Board of Education. Not only do these two propositions both reveal the gross ignorance of elected officials of what biological sex actually is (see <https://www.scientificamerican.com/article/the-new-science-of-sex-and-gender/>), they created fan fair for "issues" that cause no actual threat of harm.

The use of moral panic is explicitly to redirect attention away from actual threats of harm and displace anger onto an issue or group of people, in this case, our vulnerable LGBTQ+ children. Dunleavy is using moral panic to redirect our attention away from his gutting of the state University system and intentional failures to adequately fund and intelligently guide education and invest in our children, who are the economic and cultural future of our state.

Blatant redirects aside, Dunleavy's denial of his intent to call out LGBTQ+ children is intentional ignorance and does nothing to prevent the actual harm it will cause. At this time, there are over 400 LGBTQ+ legislative bills under consideration that many, like Dunleavy, have defended as a "difference of opinion," with a refusal to be held accountable for the real harm they will cause to real people.

The Trevor Project, a national advocacy and support group recently published this statement:

"Our 2022 U.S. National Survey on LGBTQ Youth Mental Health by State found that 54% of trans and nonbinary youth in Florida seriously considered suicide in the past year, and 20% made an attempt. Transgender young people consistently report disproportionate rates of suicide risk compared to their peers, and the increased politicization of their very existence continues to harm their mental health and sense of self."

As a licensed professional counselor with 20 years of experience in the behavioral health field, I can testify to the truth of these findings. Replication studies within the fields of sociology, psychology,

endocrinology, and pediatric health have all displayed that engagement with gender affirming care and environment consistently reduce patient stress, depression, anxiety, suicidal experiences, and inflammation (an immune reaction). No studies have ever displayed that receiving affirming care or treatment is regretted or causes health or psychological harm. Denial of gender affirming care, education, and supports HAVE been shown to increase risk of harm to these children and further increase implicit bias and unfair treatment of our fellow citizens.
