SUBJ: LAA Vehicle Replacement

This memo is to request Legislative Council approval to replace the 17-year-old van currently used for LAA day-to-day operations in Juneau.

As you know, Alaska's challenging climate and the chemicals used on the roads in the winter are tough on vehicles. The longer the van is in service, the more serious and frequent are the maintenance issues, significantly increasing repair and maintenance costs, as well as shop time, which impacts the Agency's ability to support the Legislature. As such, LAA seeks to purchase a new van.

Several dealers in Alaska, as well as the Lower 48, were contacted to request price quotes for a full-size cargo van with all-wheel drive. We received a total of three quotes:
