### Analysis

This legislation consolidates authority for regulating geothermal resources in the state under the Alaska Oil and Gas Conservation Commission (AOGCC). This activity currently falls under the Commission's authority.

The Alaska Oil and Gas Conservation Commission does not anticipate fiscal impact from this legislation.
