Guns simply have no place in K-12 schools. Guns expose school communities to risks, including increasing the risk of unintentional shootings. I urge you to consider the flaws of SB 173 which proposes to make school children safer by requiring certain teachers and school staff to carry firearms at school. Please never let this measure move from committee. It will not make our kids safer.

We need fewer guns in schools, not more guns. Any firearms utilized by authorities in a confrontation with a school shooter should be in the hands of law enforcement personnel.

Perhaps the measure was referred to Senate Labor and Commerce because the only benefit it would provide is to the companies that sell firearms.

If one really wants to effectively address the issue of reducing gun violence, including reducing the number of deaths of innocent children in school shootings, there are measures that have proven successful. These include laws such as those proposed in two measures before the Legislature regarding secure storage of firearms and emergency protective orders.

The law now on the books about firearms on school grounds received a high degree of attention from Alaska lawmakers including spirited floor debate, and it serves us well.

As a lifelong Alaskan and retired public school teacher of 25 years I urge you to oppose SB 173.

Not only have I lived in Alaska and worked for the Fairbanks North Star Borough School District for more than two consecutive decades, I have a niece residing in Anchorage with young children in the public schools there. As many of you also no doubt have young family in our public schools.

The intent to protect children is strong but K-12 schools are no place for guns. No matter the training school community members may receive, those who carry guns are going to be exposed to fearful events in the heat of a stressful situation where they will most certainly become a danger to others in their school community.

Additionally, SB 173 deliberately puts more guns in schools thus likely putting them into the hands of children. I speak from many years in K-8 public school classrooms.
