# Institutional Substance Abuse Treatment Programs

---

## SB91 Funding Target Areas

- Increase availability of substance abuse services and assessments;
- Expand services available to female offenders;
- Expand services available to pretrial offenders;
  - Development of Medication Assisted Treatment Re-entry (MATR) programming
  - Implementation of overdose intervention response program
- Improve referral process for offenders upon reentry.
