## FISCAL NOTE ANALYSIS

BILL NO. HB 161

### Analysis

House Bill 161 would direct 25% of the filing fees received by the Alaska Court System during the previous fiscal year to the civil legal services fund account. The court system currently deposits all filing fees it receives into the general fund, and HB 161 will not change that. The bill affects what is done with those funds thereafter, and thus does not affect the court system.

The court system therefore submits this zero fiscal note.
