

**HOUSE BILL NO. 228**

THIRTY-THIRD LEGISLATURE - SECOND SESSION

**A BILL**

**FOR AN ACT ENTITLED**

1   **"An Act establishing the Alaska mental health and psychedelic medicine task force; and**  
2   **providing for an effective date."**

3   **BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:**

4       **\* Section 1.** The uncoded law of the State of Alaska is amended by adding a new section  
5   to read:

6           ALASKA MENTAL HEALTH AND PSYCHEDELIC MEDICINE TASK FORCE.

7   (a) The Alaska mental health and psychedelic medicine task force is established in the  
8   Department of Commerce, Community, and Economic Development. The purpose of the task  
9   force is to

10                   (1) assess the potential use of psychedelic medicine in addressing the state's  
11   ongoing mental health crisis;

12                   (2) consider barriers to implementation and equitable access;

13                   (3) consider and recommend licensing and insurance requirements for  
14   practitioners in the state in the event that psychedelic medicines are federally reclassified and

1 approved by the United States Food and Drug Administration; and

2 (4) consider legal and regulatory pathways to the legalization of psychedelic  
3 medicines in the state, and the potential effects of the medicines on public health.

4 (b) The task force consists of the following members:

5 (1) the commissioner of health, or the commissioner's designee;

6 (2) the commissioner of military and veterans' affairs, or the commissioner's  
7 designee;

8 (3) the commissioner of commerce, community, and economic development,  
9 or the commissioner's designee;

10 (4) one member representing mental health issues in the state, selected by the  
11 state chapter of a national alliance focused on mental health and mental illness;

12 (5) two members representing the health care needs of Alaska Native  
13 communities, selected by the board of directors of the Alaska Native Health Board, one of  
14 whom must be a recognized indigenous ethnoherbalist;

15 (6) one member representing the health care needs of survivors of domestic  
16 violence and sexual assault, selected by the Alaska Network on Domestic Violence and  
17 Sexual Assault;

18 (7) one member representing the psychiatric profession, selected by the  
19 governing body of the Alaska Psychiatric Association;

20 (8) one member of the faculty of the division of population health sciences at  
21 the University of Alaska, selected by the president of the University of Alaska;

22 (9) one member of the senate appointed by the president of the senate;

23 (10) one member of the house of representatives appointed by the speaker of  
24 the house of representatives;

25 (11) up to three members selected by the task force, once assembled, that the  
26 task force determines would serve the purpose of the task force; the task force is not required  
27 to make an appointment under this paragraph.

28 (c) The task force shall elect a chair from among its members.

29 (d) A vacancy on the task force shall be filled in the same manner as the original  
30 selection or appointment.

31 (e) Members of the task force serve without compensation but are entitled to per diem

1 and travel expenses authorized for boards and commissions under AS 39.20.180.

2 (f) The task force shall

3 (1) meet at least four times to fulfill the purpose of the task force;

4 (2) ensure members are available for legislative hearings; and

5 (3) on or before December 31, 2024, submit to the senate secretary, the chief  
6 clerk of the house of representatives, and the governor a report consisting of its  
7 recommendations, and notify the legislature that the report is available.

8 (g) The task force terminates when the First Regular Session of the Thirty-Fifth  
9 Alaska State Legislature convenes.

10 (h) In this section, "task force" means the Alaska mental health and psychedelic  
11 medicine task force.

12 \* **Sec. 2.** This Act takes effect immediately under AS 01.10.070(c).
