**A BILL**

**FOR AN ACT ENTITLED**

**"An Act establishing the Alaska mental health and psychedelic medicine task force; and  
providing for an effective date."**

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:**

**\* Section 1.** The uncodified law of the State of Alaska is amended by adding a new section  
to read:

**ALASKA MENTAL HEALTH AND PSYCHEDELIC MEDICINE TASK FORCE.**

(a) The Alaska mental health and psychedelic medicine task force is established in the  
Department of Commerce, Community, and Economic Development. The purpose of the task  
force is to prepare for the potential medicalization of psychedelic medicines by the United  
States Food and Drug Administration; to make policy recommendations to the Alaska State  
Legislature concerning insurance and licensure, given the unique nature of the administration  
of psychedelic medicines; and to ensure the state is prepared if psychedelic medicines become  
available for prescription. The task force shall

(1) assess the potential use of psychedelic medicine in addressing the state's

1 ongoing mental health crisis;

2 (2) consider barriers to implementation and equitable access;

3 (3) consider and recommend licensing and insurance requirements for  
4 practitioners in the state in the event that psychedelic medicines are federally reclassified and  
5 approved by the United States Food and Drug Administration; and

6 (4) consider legal and regulatory changes that could be necessary in the state  
7 after federal medical approval of psychedelic medicines.

8 (b) The task force consists of the following members:

9 (1) the commissioner of health, or the commissioner's designee;

10 (2) the commissioner of military and veterans' affairs, or the commissioner's  
11 designee;

12 (3) the commissioner of commerce, community, and economic development,  
13 or the commissioner's designee;

14 (4) one member representing mental health issues in the state, selected by the  
15 state chapter of a national alliance focused on mental health and mental illness;

16 (5) two members representing the health care needs of Alaska Native  
17 communities, selected by the board of directors of the Alaska Native Health Board;

18 (6) one member representing the health care needs of survivors of domestic  
19 violence and sexual assault, selected by the Alaska Network on Domestic Violence and  
20 Sexual Assault;

21 (7) one member representing the psychiatric profession, selected by the  
22 governing body of the Alaska Psychiatric Association;

23 (8) one member representing licensed therapists or counselors, selected by the  
24 board of directors of the Alaska Addiction Professionals Association;

25 (9) one member of the faculty of the division of population health sciences at  
26 the University of Alaska, selected by the president of the University of Alaska;

27 (10) one member of the senate appointed by the president of the senate;

28 (11) one member of the house of representatives appointed by the speaker of  
29 the house of representatives;

30 (12) up to three members selected by the task force, once assembled, that the  
31 task force determines would serve the purpose of the task force; the task force is not required

1 to make an appointment under this paragraph.

2 (c) The task force shall elect a chair from among its members.

3 (d) A vacancy on the task force shall be filled in the same manner as the original  
4 selection or appointment.

5 (e) Members of the task force serve without compensation.

6 (f) The task force shall

7 (1) meet at least four times to fulfill the purpose of the task force; and

8 (2) on or before December 31, 2024, submit to the senate secretary, the chief  
9 clerk of the house of representatives, and the governor a report consisting of its  
10 recommendations, and notify the legislature that the report is available.

11 (g) The task force terminates when the First Regular Session of the Thirty-Forth  
12 Alaska State Legislature convenes.

13 (h) In this section, "task force" means the Alaska mental health and psychedelic  
14 medicine task force.
