If you are being forced to trade sex for money, drugs or a place to stay or if you are being forced to do any other activity (housework, farm work, fishing, retail work, or restaurant work) where you are **THREATENED** if you want to leave, then this is human trafficking and you are protected under the United States and Alaska State Law.
  - Definition of **“commercial sex act”**: A commercial sex act means **any sex act on account of which anything of value is given to or received by any person**. Anything of value could include food, shelter, protection, gifts, clothing, drugs, etc.
