FISCAL NOTE ANALYSIS

BILL NO. SB197

Analysis

This legislation requires the Alaska Housing Finance Corporation (AHFC) to adopt a state residential building code. It requires the examination required for residential contractor endorsement applicants to include a test of the person's knowledge of that code to obtain or renew an endorsement. It also changes references to the "state building code" to the "state residential building standards."

If this bill passes the de minimis cost of amending regulations and the cost of the associated printing and postage will be absorbed in the division's existing budget authority. The Division of Corporations, Business, and Professional Licensing does not anticipate fiscal impact from this legislation.
