FY2024 Budget Accomplishments

Significant Item Review

\$800.0

Alaska Psychiatric Institute

- 10 seat Jail-Based and 10 seat Outpatient Restoration Program – Community
- Both programs are staffed and beginning to take patients

\$324.0

Complex Care Unit

- Tracking cases, payments, levels of care, and recommendations from providers
- Case Response Team (CRT) and Complex Care Committee (CCC) working to streamline state system processes and improving case outcomes



FY2024 Budget Accomplishments

Significant Item Review

\$385.0

Office of Children's Services

- Support for position in Office of Children's Services to assist foster youth who are transitioning into adulthood.
- Additional Independent Living Program support



FY2025 Significant Items

Statutory Designed Program Receipts

Item 1

Alaska Pioneer Homes Pharmacy Program

- \$500.0 increase in receipt authority in FY2025
- Increases in the costs of pharmaceutical and increased utilization necessitate the increment.

Alaska Pioneer Homes Pharmacy Program

- \$1,000.0 increase in receipt authority in FY2024
- Included in Supplemental Budget

Alaska Psychiatric Institute (API)

- Establish standalone budget appropriation
- API was own appropriation in FY2022 prior to the reorganization of the Department of Health and Social Services

- Designated Evaluation and Treatment (DES/DET) and Complex Care Unit aligned into renamed allocation part of Departmental Support Services

Item 3

Alaska Psychiatric Institute

- \$200.0 GF/MH (UGF)
- Support SHARP-3 student loan repayment program for licensed practitioners in the hospital

Item 5

Legal Services to Support Class Action Litigation

- \$1,000.0 GF (UGF)
- Support the Department of Law response, outside council, and expert witness testimony

FY2025 Significant Items

Foster Care Base Rate Increase

Item 4

Office of Children's Services

- \$5000.0 Total (\$2,548.9 GF, \$1,392.8 Fed, \$1,058 GF Match)
- Update of foster care base rates, last updated July 1, 2018.
- Rate increases are vital to retain and recruit foster families to serve vulnerable children.
- Updated methodology better reflects the cost of living in Alaska.
