Co-Chair Bishop and Co-Chair Giessel:

Thank you for the opportunity to present SB 198 State Land for Remote Recreational Cabin Sites to the committee on Wednesday, January 31, 2024. During my presentation, committee members requested follow-up information regarding two matters:

Request for a chart of Department of Natural Resources programs that dispose of or lease state land.

- The requested chart is attached to this letter.

Does the existing process for reclassification of state lands include a best interest finding?

- The Division of Mining, Land and Water (Division) has a statutory process for classification/reclassification of state land under AS 38.04.065. This statute requires public notice and involvement under AS 38.05.945.
- The Division also has regulations that guide our plan processes at 11 AAC 55.
- The classification/reclassification process does not require a best interest finding pursuant to AS 38.05.035(e).

All actions and decisions by the Department are appealable.

Regardless of the decision process, the appeal and request for reconsideration processes provide administrative recourse for people who are aggrieved by or affected by a decision issued by the department by allowing them to seek the Commissioner's review of the decision.
