RE: AGDC's Response to House State Affairs Committee Question on March 6, 2025

Dear Representative Carrick:

This letter is in response to a question raised in the March 6, 2025, meeting of the House State Affairs Committee by Representative Vance regarding House Bill 119, specifically regarding permits pertaining to the inactive Alaska Stand Alone Pipeline (ASAP) Project.

When do the permits for the ASAP Project expire?

The Alaska Gasline Development Corporation (AGDC) previously obtained Federal and State of Alaska permits and authorizations for the ASAP Project. The scope of the ASAP Project included a Fairbanks lateral pipeline. These permits and authorizations are detailed as follows.

Federal Permits and Authorizations:

- U.S. Army Corps of Engineers of Engineers Environmental Impact Statement (EIS) and Supplemental EIS
- U.S. Army Corps of Engineers and Bureau of Land Management Joint Record of Decision
- U.S. Army Corps of Engineers Wetland Proffered Permit (*This permit was not finalized*)
- U.S. Army Corps of Engineers Cultural Resources Programmatic Agreement
- Cultural Resources Management Plan
- U.S. Fish and Wildlife Service Biological Opinion

State of Alaska Permits and Authorizations

- Alaska Department of Natural Resources Right-of-Way Lease (expires July 25, 2041)
- Alaska Department of Environmental Conservation 401 Water Quality Certification (*Linked to U.S. Army Corps of Engineers Permit above*)
- Alaska Department of Transportation and Public Facilities Highway Use Agreement

Unless specifically noted above, the listed permits and authorizations do not have specific expiration dates.
