The Department of Health received the following questions during the presentation to the House Finance Committee on March 3, 2025, about the Medicaid Enrollment and Spending in Alaska (MESA) report:

## What cost containment methods have been implemented?

The attached Annual Medicaid Reform Report FY2024 includes information about Medicaid cost containment. Activities include federal tribal reimbursement, pharmacy preferred drug lists and prospective drug utilization reviews, and utilization management services.

#### What are the fraud, waste, and abuse efforts of the department?

The attached Joint Legislative Fraud, Waste, and Abuse report includes information about activities conducted by the Department of Law and Department of Health to prevent Medicaid fraud, waste, and abuse.
