### MEMORANDUM

**SUBJECT:** Cybersecurity Licensing, Maintenance, and Technical Support Renewal

This is to request Legislative Council consideration and approval to renew the annual cybersecurity licensing, maintenance, and technical support services protecting the legislative network and information technology infrastructure.

The consequence of not approving the renewal is a serious risk to the Legislature, including exposure of legislative data and network infrastructure to malware and unauthorized access. Such exposure would require legislative resources be disconnected from the internet, including removing access to the akleg.gov website, BASIS, legislative mail, and committee and floor session information.

LAA has secured quotes from two different vendors and recommends Legislative Council award the renewal to Structured in an amount not to exceed \$99,894.00, which is the current vendor and lowest quote.
